Dear Secretary Andanar:

In compliance with the President's directive to operationalize the constitutional mandate of the people's right to information through the issuance of Executive Order No. 2, series of 2016, we are submitting the DOLE's report on its implementation.

As of 2nd Quarter, 2017, the DOLE received a total of one hundred ten (110) requests. Eighty (80) of these requests were approved and thirty (30) were either denied or referred to appropriate offices. Only ten (10) DOLE Offices namely, Financial and Management Service, Bureau of Working Conditions, Regional Office Nos. 3, 4-A, 5, 6, 7, NIR, 10 and 12 received information requests, as shown below:
