In compliance to the President's directive to operationalize the Constitutional mandate of the People's right to information thru the issuance of Executive Order No. 2, series of 2016, we are submitting the DOLE's FOI report for the 4th quarter of CY 2018.

A total of one hundred thirty eight (138) requests where received by eight (8) DOLE offices wherein ninety one (91) requests were approved and forty seven (47) were denied or referred to other agencies, as shown below:

The reasons for denying the forty even (47) requests are as follows:

1. Inventory of Exceptions: Fifteen (15) requests are included in the Inventory of Exceptions to the right to access per information to Executive Order No.02 (s. 2016); and

2. Info not maintained: Thirty two (32) requests are not being handled, maintained, or stored by the agency but another agency holds the information.

In relation to the submission of the 3rd quarter FOI requests reported to PCOO on October 30, 2018, the DOLE received additional certifications¹ that the office received no FOI request as of the quarter.

Further, twenty six (26) DOLE offices² did not receive FOI request for this quarter.

We are also submitting the attached **FOI Revised Registry Sheets** of all FOI Requests received by the department and the **Summary of the Status of Processed Requests**.
