**DECLARING GILCOR PRINTING PRESS AS THE SINGLE
CALCULATED RESPONSIVE BIDDER FOR THE INFORMATION AND
PUBLICATION SERVICE'S PROJECT "PRINTING OF 2020 PHILIPPINE LABOR"**

WHEREAS, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the abovementioned project with an Approved Budget for the Contract (ABC) of ₱612,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE Website and conspicuous places at the DOLE's premises from January 19, 2020 to January 22, 2020;

WHEREAS, said project is included in the Indicative FY 2020 Annual Procurement Plan of the Department;

WHEREAS, in response to the advertisement, Gilcor Printing Press and Quasar Inc. purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat on February 7, 2020 to February 10, 2020;

WHEREAS, the Pre-bid Conference originally scheduled on January 22, 2020;

WHEREAS, Notice of Postponement was issued on the Opening of Bids which was originally scheduled on February 05, 2020 and has been moved to February 07, 2020 and from February 07, 2020 has been moved to February 10, 2020;

WHEREAS, the submission and opening of bids scheduled on February 10, 2020 were attended by two (2) bidders, namely: (1) Gilcor Printing Press and (2) Quasar, Inc. Said bidders submitted their technical and financial envelopes. After preliminary examination, the technical proposals of Gilcor Printing Press were rated as "passed" hence, the BAC opened its financial envelopes which were also rated as "passed", while Quasar Inc. were rated as "failed" in view of non-compliance with Section II-ITB Clause 20 of the Bidding Documents;

WHEREAS, the BAC informed the representative for Quasar Inc. that they have an option to file for a Motion for Reconsideration (MR) within three (3) days from the date of opening of bids;

WHEREAS, no MR was received by the BAC Secretariat from Quasar Inc.;

WHEREAS, the BAC - TWG in its bid evaluation report dated February 17, 2020 as duly concurred by the members of the BAC, examined and evaluated the bid proposal of Gilcor Printing Press;

WHEREAS, based on the evaluation of the bids conducted by the DOLE-BAC Technical Working Group, Gilcor Printing Press complied with the mandatory minimum specifications of the said project which was presented during the BAC meeting on February 17, 2020 Gilcor Printing Press was declared as the Single Calculated Bidder per BAC Resolution No. 035, Series of 2020;

WHEREAS, BAC Secretariat sent a letter to Gilcor Printing Press requesting for submission of post-qualification documents;

WHEREAS, Gilcor Printing Press submitted additional documents for post-qualification;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Gilcor Printing Press, its bid has been found to be responsive;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare **Gilcor Printing Press** as the **Single Calculated Responsive Bidder** for the **Information and Publication Service's** project "**Printing of 2020 Philippine Labor**";
- b. To award the "**Printing of 2020 Philippine Labor**" for the **Information and Publication Service's** project to **Gilcor Printing Press**; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.


