The Bidding Documents may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the DOLE, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
5. All interested bidders shall be allowed to attend and participate in the discussion during the Pre-Bid Conference.
6. The Pre-Bid Conference and Submission and Opening of Bids shall be held at the LGLC, 2nd Floor, Blas F. Ople Hall, San Jose Street, Intramuros, Manila.


