4. The complete set of Bidding Documents may be purchased at the DOLE BAC Secretariat upon payment of non-refundable price of bid documents indicated above. The Bidding Documents may also be downloaded free of charge from the website of the Philippine

Government Electronic Procurement System (PhilGEPS) and the website of the DOLE, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

5. All interested bidders shall be allowed to attend and participate in the discussion during the Pre-Bid Conference.


