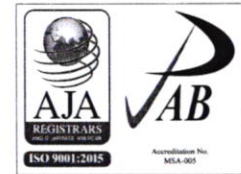

**DECLARING EASTERN TELECOMMUNICATIONS PHILIPPINES, INC. AS THE  
LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT  
“SUBSCRIPTION OF 30MBPS INTERNET LEASED LINE CONNECTION VIA  
FIBER OPTIC CABLE FOR PUBLIC EMPLOYMENT SERVICE OFFICE (PESO)  
PORTAL OF THE BUREAU OF LOCAL EMPLOYMENT”**

**WHEREAS**, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the bidding of the above-mentioned project with an Approved Budget for the Contract (ABC) of ₱300,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE website and conspicuous places at the DOLE’s premises from 12 August 2020 to 01 September 2020;

**WHEREAS**, the above-mentioned project is included in the FY 2020 Annual Procurement Plan of the Department;

**WHEREAS**, in response to the advertisement, Eastern Telecommunications Philippines, Inc. and PLDT, Inc. purchased the bidding documents from the DOLE Bids and Awards Committee (BAC) Secretariat;

**WHEREAS**, the Pre-bid Conference scheduled on 19 August 2020 was rescheduled twice, 25 August 2020 and 28 August 2020 and no bidder attended the conference;

**WHEREAS**, the submission and opening of bids originally scheduled on 01 September 2020 was rescheduled to 10 September 2020;

**WHEREAS**, during submission and opening of bids, Eastern Telecommunications Philippines, Inc. and PLDT, Inc. submitted their two envelopes containing the eligibility, technical and financial requirements. Upon eligibility check, the technical component of the two (2) bidders were rated “**passed**”. Hence, the BAC-Technical Working Group (TWG) opened the financial envelopes which were likewise found to be compliant and recommended for bid evaluation.

**WHEREAS**, the BAC instructed the BAC-TWG to conduct a detailed evaluation of bids and prepare the necessary Bid Evaluation Report;

**WHEREAS**, based on the evaluation of the bids conducted by the DOLE-BAC TWG, Eastern Telecommunications Philippines, Inc. was declared as the Lowest Calculated and Responsive Bidder per BAC Resolution No. 083, Series of 2020;

**WHEREAS**, on 15 September 2020, the BAC Secretariat sent a notice to Eastern Telecommunications Philippines, Inc., requesting for submission of post-qualification documents;

**WHEREAS**, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Eastern Telecommunications Philippines, Inc., its bid has been found to be responsive;


**NOW, THEREFORE, We**, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare **Eastern Telecommunications Philippines, Inc.** as the Lowest Calculated and Responsive Bidder for the project “**Subscription of 30Mbps Internet Leased Line Connection via Fiber Optic Cable for Public Employment Service Office (PESO) Portal of the Bureau of Local Employment**”;
- b. To award the project “**Subscription of 30Mbps Internet Leased Line Connection via Fiber Optic Cable for Public Employment Service Office (PESO) Portal of the Bureau of Local Employment**” to Eastern Telecommunications Philippines, Inc. at a contract price of **₱134,400.00**; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.

**RESOLVED**, at the DOLE Main Building, Intramuros, Manila, this 22<sup>nd</sup> day of September 2020.






