WHEREAS, the Department of Labor and Employment (DOLE), through the Planning Service (PS), requisitioned for the "Supply and Delivery of Five (5) units Branded Dot Matrix Printer" with a total Approved Budget for the Contract of ₱215,000.00;

WHEREAS, the said activity is included in the 2020 Annual Procurement Plan of the Department.

WHEREAS, DOLE BAC Resolution No. 074, Series of 2020 Recommending Small Value Procurement as the mode of procurement for the abovementioned project was signed on 10 September 2020;

WHEREAS, DOLE advertised the Request for Price Quotation for the procurement of the above-mentioned project in the Philippine Government E-Procurement System (PhilGEPS), and DOLE website from 11 to 16 September 2020;



WHEREAS, the BAC-TWG recommended Pronet Systems Integrated Network Solutions, Inc. as the Lowest Calculated Responsive Bidder for the project "**Supply and Delivery of Five (5) units Branded Dot Matrix Printer**" based on the Abstract of Price Quotations and was declared **responsive** as indicated in the post-qualification report under small value procurement;


