DECLARING REMAX INTERNATIONAL, INC. AS THE SINGLE CALCULATED RESPONSIVE BIDDER FOR THE PROJECT "SUPPLY AND DELIVERY OF TWENTY (20) UNITS LAPTOP COMPUTERS (BRANDED – BRAND NEW)"

WHEREAS, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the above-mentioned project with an Approved Budget for the Contract (ABC) of ₱1,600,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE website, and conspicuous places at the DOLE's premises from 02 September to 22 September 2020;

WHEREAS, said project is included in the approved 2020 Annual Procurement Plan of the Department;

WHEREAS, in response to the advertisement, only Remax International, Inc. purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat on 22 September 2020;

WHEREAS, only Remax International, Inc. attended the Pre-bid Conference scheduled on 10 September 2020;

WHEREAS, the submission and opening of bids scheduled on 22 September 2020 was attended only by Remax International, Inc. Said bidder submitted its technical and financial envelopes. After the preliminary examination, the eligibility and technical requirements of Remax International, Inc. was rated as "**passed**". Hence, the BAC - Technical Working Group (BAC-TWG) opened the financial envelope which was likewise found to be compliant and recommended for bid evaluation;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by **Remax International, Inc.** its bid has been found to be responsive;

NOW, THEREFORE, We, the members of the DOLE Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


- a. To declare **Remax International, Inc.** as the Single Calculated Responsive Bidder for the project "Supply and Delivery of Twenty (20) units Laptop Computers (Branded – Brand New)";
- b. To award the "Supply and Delivery of Twenty (20) units Laptop Computers (Branded – Brand New)" to **Remax International, Inc.**; and

c. To recommend for approval by the DOLE Undersecretary the foregoing findings


