**DECLARING GILCOR PRINTING PRESS AS THE
SINGLE CALCULATED RESPONSIVE BIDDER FOR THE PROJECT
“PRINTING OF ENHANCED CAREER GUIDANCE AND EMPLOYMENT
COACHING (CGEC) MODULES”**

WHEREAS, DOLE BAC Resolution No. 250, Series of 2019 declaring the first bidding for the above-mentioned project a failure was approved on 13 December 2019;

WHEREAS, DOLE BAC Resolution No. 009, Series of 2020 declaring the re-bidding for the above-mentioned project a failure was approved on 17 January 2020;

WHEREAS, the DOLE advertised Invitation for Negotiation of the above-mentioned project with a total Approved Budget for the Contract of ₱100,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE Website and conspicuous places at the DOLE's premises from 18 to 22 January 2020;

WHEREAS, in response to the advertisement, four bidders attended the negotiation scheduled on 22 January 2020, namely: (1) Gilcor Printing Press; (2) JNJI Enterprise; (3) Quasar, Inc.; and (4) Metrocolor Corporation;

WHEREAS, the submission and opening of bids originally scheduled on 05 February 2020 was re-scheduled twice, 07 February 2020 and 10 February 2020, respectively;

WHEREAS, during the submission and opening of bids, only Gilcor Printing Press submitted its technical and financial envelopes. Upon eligibility check, the eligibility and technical requirements of the bidder was rated as “**passed**”. Hence, the BAC-Technical Working Group (TWG) opened the financial envelope which was likewise found to be compliant and recommended for bid evaluation. The BAC approved the TWG's recommendation;

WHEREAS, based on the evaluation of the bids conducted by the BAC-TWG, Gilcor Printing Press was declared as the Single Calculated Bidder per BAC Resolution No. 029, Series of 2020;

WHEREAS, on February 14, 2020, Gilcor Printing Press submitted its additional documents for post qualification;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Gilcor Printing Press, its bid has been found to be responsive;


NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


