**DECLARING ICT SECURITY AND INVESTIGATION AGENCY, INC. AS THE
LOWEST CALCULATED RESPONSIVE BIDDER FOR THE PROJECT
“PROVISION OF SECURITY SERVICES FOR A PERIOD OF ONE (1) YEAR IN
THE DOLE- CENTRAL OFFICE FROM OCTOBER 2020 TO OCTOBER 2021”**

WHEREAS, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the above-mentioned project with an Approved Budget for the Contract (ABC) of ₱17,211,176.79 in the Philippine Government E-Procurement System (PhilGEPS), DOLE website, and conspicuous places at the DOLE’s premises from 8 July 2020 to 29 July 2020;

WHEREAS, said project is included in the approved Fiscal Year (FY) 2020 Annual Procurement Plan of the Department;

WHEREAS, in response to the advertisement, two (2) prospective bidders, namely: 1) ICT Security and Investigation Agency, Inc., and 2) Blackwater Philippines Security Solutions Inc. purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat from 20 July 2020 to 28 July 2020;

WHEREAS, the Pre-bid Conference scheduled on 15 July 2020 was attended by three (3) bidders, namely: 1) Golden 5Z Security & Investigation Agency, (2) Blackwater Philippines Security Solutions Inc., and 3) Northcom Security & Investigation Agency;

WHEREAS, Supplemental/Bid Bulletin No. 02, Addendum No. 01 and 02, Series of 2020, clarify or amend some provisions originally indicated in the Bidding Documents specifically on the Annex A: Salary Computation of Security Guards and General Conditions on the Terms of Reference, were issued to the bidders;

WHEREAS, the submission and opening of bids originally scheduled on 29 July 2020 has been moved thrice to 04 August, 25 August and 28 August 2020 and was attended by two (2) bidders, namely: 1) ICT Security and Investigation Agency, Inc., and (2) Blackwater Philippines Security Solutions Inc. Said bidders submitted their technical and financial envelopes. After the preliminary examination, the eligibility and technical requirements of the two (2) bidders were rated as **“passed”**.

Hence, the BAC - Technical Working Group (BAC-TWG) opened the financial envelopes which were likewise found to be compliant and recommended for bid evaluation;

WHEREAS, based on the evaluation of the bids conducted by the DOLE BAC Technical Working Group on 04 September 2020, ICT Security and Investigation Agency, Inc. was declared as the Lowest Calculated Bidder per BAC Resolution No. 073, Series of 2020 for the project "***Provision of Security Services for a period of One (1) Year in the DOLE-Central Office from October 2020 to October 2021***";

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by ICT Security and Investigation Agency, Inc., its bid has been found to be responsive;


NOW, THEREFORE, We, the members of the DOLE Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


