**DECLARING INDUSTRIA PHILIPPINES AND GLOBAL CORP. AS  
THE SINGLE CALCULATED RESPONSIVE BIDDER FOR THE ADMINISTRATIVE  
SERVICE'S PROJECT "PROVISION OF COMPREHENSIVE PREVENTIVE  
MAINTENANCE AND REPAIR SERVICES OF THE THREE (3) ELEVATOR UNITS  
LOCATED AT THE DOLE MAIN BUILDING"**

**WHEREAS**, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the abovementioned project with an Approved Budget for the Contract (ABC) of ₱720,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE Website and conspicuous places at the DOLE's premises from 06 August 2020 to 08 September 2020;

**WHEREAS**, said project is included in the Indicative FY 2020 Annual Procurement Plan of the Department;

**WHEREAS**, in response to the advertisement, Industria Philippines and Global Corp. purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat on 08 September 2020;

**WHEREAS**, Notice of Postponement was issued on the Pre-bid Conference originally scheduled on 25 August 2020 and has been moved to 28 August 2020;

**WHEREAS**, Supplemental Bid Bulletin No. 03 was issued to amend and clarify some provisions originally indicated in the Bidding Documents;

**WHEREAS**, the submission and opening of bids scheduled on 08 September 2020 and likewise moved to 10 September 2020 was attended by lone bidder Industria Philippines and Global Corp. Said bidder submitted its technical and financial envelope. After preliminary examination, the technical proposal of Industria Philippines and Global Corp. was rated as "passed" hence, the BAC opened its financial envelopes which was also rated as "passed";

**WHEREAS**, based on the evaluation of the bids conducted by the DOLE-BAC Technical Working Group, Industria Philippines and Global Corp. complied with the

mandatory minimum specifications of the said project which was presented during the BAC meeting on 10 September 2020, Industria Philippines and Global Corp. was declared as the Single Calculated Bidder per BAC Resolution No. 080, Series of 2020;

**WHEREAS**, BAC Secretariat sent a letter to Industria Philippines and Global Corp. requesting for submission of post-qualification documents;

**WHEREAS**, on 17 September 2020, Industria Philippines and Global Corp. submitted additional documents for post-qualification;

**WHEREAS**, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Industria Philippines and Global Corp., its bid has been found to be responsive;

**NOW, THEREFORE**, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare **Industria Philippines and Global Corp.** as the **Single Calculated Responsive Bidder** for the Administrative Service's project "**Provision of Comprehensive Preventive Maintenance and Repair Services of the Three (3) Elevator Units located at the DOLE Main Building**";
- b. To award the "**Provision of Comprehensive Preventive Maintenance and Repair Services of the Three (3) Elevator Units located at the DOLE Main Building**" for the Administrative Service's project to **Industria Philippines and Global Corp.**; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.


