DECLARING PRONET SYSTEMS INTEGRATED NETWORK SOLUTION, INC. AS THE SINGLE CALCULATED RESPONSIVE BIDDER FOR ITEM 3, AND AURORA (O.A.) PHILS., INC. AS THE LOWEST CALCULATED RESPONSIVE BIDDER FOR ITEMS 1 AND 2 FOR THE PROJECT "SUPPLY AND DELIVERY OF EXECUTIVE TABLE, EXECUTIVE CHAIR AND SMART TV FOR THE OFFICE OF THE ASSISTANT SECRETARY FOR LEGAL AND OVERSEAS OPERATION"

WHEREAS, the Department of Labor and Employment (DOLE), through the Office of the Assistant Secretary for Legal and Overseas Operation, requisitioned for the project "Supply and Delivery of Executive Table, Executive Chair and Smart TV for the Office of the Assistant Secretary for Legal and Overseas Operation" with a total Approved Budget for the Contract of ₱100,000.00;

WHEREAS, the BAC Resolution No. 066, Series of 2020 Recommending Small Value Procurement as the mode of procurement for the abovementioned project was signed on August 18, 2020;

WHEREAS, DOLE advertised the Request for Price Quotation for the bidding of the above-mentioned project in the Philippine Government E-Procurement Systems (PhilGEPS), DOLE website from August 19, 2020 to August 26, 2020;

WHEREAS, in response to the advertisement, three (3) bidders namely; 1) Pronet Systems Integrated Network Solution, Inc., 2) Aurora (O.A.) Phils, Inc. and 3) Don Jay Enterprises submitted their price proposals and is summarized in the Abstract of Price Quotations attached as Annex A;

WHEREAS, based on the Abstract for Price Quotations submitted by BAC-TWG, Aurora (O.A.) Philippines, Inc. meet the items specification requirements for the project "Supply and Delivery of Executive Table and Executive Chair while Pronet Systems Integrated Network Solution, Inc. as lone bidder for the Smart TV both complied with the minimum requirements as stipulated in the technical specifications of the said project.

WHEREAS, Pronet Systems Integrated Network Solution, Inc. and Aurora (O.A.) Philippines, Inc. submitted their financial and eligibility documents for post-qualification;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Aurora (O.A.) Phils., Inc. and Pronet Systems Integrated Network Solution, Inc., their bids has been found to be responsive;

WHEREAS, the BAC-Technical Working Group (TWG) recommended, Aurora (O.A.) Phils., Inc. as the Lowest Calculated Responsive Bidder for items 1 and 2 and Pronet Systems Integrated Network Solution, Inc., as the Single Calculated Responsive Bidder for item 3 of the project "Supply and Delivery of Executive Table, Executive Chair and Smart TV for the Office of the Assistant Secretary for Legal and Overseas Operation" based on the Abstract of Price Quotation and was declared **responsive** as indicated in the post-qualification report under Small Value Procurement;

NOW, THEREFORE, for and in consideration of the foregoing, **We**, the members of the DOLE BAC hereby resolves as it is hereby **RESOLVED** that:

- a. To declare **Pronet Systems Integrated Network Solution, Inc.** as the Single Calculated Responsive Bidder for item 3, and **Aurora (O.A.) Phils., Inc.** as the Lowest Calculated Responsive Bidder for items 1 and 2 of the project "**Supply and Delivery of Executive Table, Executive Chair and Smart TV**";
- b. To award the project "**Supply and Delivery of Executive Table, Executive Chair and Smart TV for the Office of the Assistant Secretary for Legal and Overseas Operation**" to (1) **Pronet Systems Integrated Network Solution, Inc.** for item 3, and (2) **Aurora (O.A.) Phils., Inc.** as the Lowest Calculated Responsive Bidder for items 1 and 2 via **Small Value Procurement**; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.
