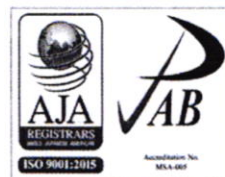

**DECLARING AVID SALES CORPORATION AS THE SINGLE  
CALCULATED RESPONSIVE BIDDER FOR THE PROJECT "SUPPLY AND  
DELIVERY OF 70-INCH ULTRA HD TV FOR THE DOLE COMMAND CENTER"**

**WHEREAS**, the Department of Labor and Employment (DOLE), through the Administrative Service (AS), requisitioned for the project "Supply and Delivery of 70-inch Ultra HD TV for the DOLE Command Center" with a total Approved Budget for the Contract of ₱120,000.00;

**WHEREAS**, the BAC Resolution No. 065, Series of 2020 Recommending Small Value Procurement as the mode of procurement for the abovementioned project was signed on 18 August 2020;

**WHEREAS**, DOLE advertised the Request for Price Quotation for the bidding of the above-mentioned project in the Philippine Government E-Procurement Systems (PhilGEPS), DOLE website from 19 August 2020 to 26 August 2020;

**WHEREAS**, in response to the advertisement, lone bidder Avid Sales Corporation submitted its price proposals and is summarized in the Abstract of Price Quotations attached as Annex A, wherein Avid Sales Corporation declared as non-responsive due to non-compliance to the inclusions;

**WHEREAS**, DOLE advertised again the Request for Price Quotation for the bidding of the above-mentioned project in the Philippine Government E-Procurement Systems (PhilGEPS), DOLE website from 04 September 2020 to 11 September 2020;

**WHEREAS**, in response to the advertisement, lone bidder Avid Sales Corporation submitted its price proposals and is summarized in the Abstract of Price Quotations attached as Annex A, wherein the price quoted by Avid Sales Corporation is lower than the ABC;

**WHEREAS**, based on the Abstract for Price Quotation Submitted by BAC-TWG, Avid Sales Corporation complied with the minimum requirements and its bid is below the approved budget of the contract for the project "Supply and Delivery of 70-inch Ultra HD TV for the DOLE Command Center";

**WHEREAS**, Avid Sales Corporation submitted its financial and eligibility documents for post-qualification;

**WHEREAS**, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Avid Sales Corporation its bid has been found to be responsive;

**WHEREAS**, the BAC-Technical Working Group (TWG) recommended, Avid Sales Corporation as the Single Calculated Responsive Bidder for the "Supply and Delivery of 70-inch Ultra HD TV for the DOLE Command Center" based on the Abstract of Price Quotation and was declared **responsive** as indicated in the post-qualification report under Small Value Procurement;

**NOW, THEREFORE**, for and in consideration of the foregoing, **We**, the members of the DOLE BAC hereby resolves as it is hereby **RESOLVED** that:

- a. To award the procurement of the project "**Supply and Delivery of 70-inch Ultra HD TV for the DOLE Command Center**" to **Avid Sales Corporation** via **Small Value Procurement**; and
- b. To recommend for approval by the DOLE Undersecretary the foregoing findings.


