**DECLARING EPARTNERS SOLUTIONS, INC. AS THE LOWEST
CALCULATED RESPONSIVE BIDDER FOR THE SUPPLY AND
DELIVERY OF FOUR (4) UNITS HIGH SPEED DOCUMENT SCANNER
(NEW - BRANDED)**

WHEREAS, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the above-mentioned project with an Approved Budget for the Contract (ABC) of ₱336,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE website, and conspicuous places at the DOLE's premises from 07 to 29 September 2020;

WHEREAS, said project is included in the 2020 Annual Procurement Plan of the Department;

WHEREAS, in response to the advertisement, three (3) prospective bidders, namely: 1) Solid Business Machines Center, Inc., 2) Epartners Solutions, Inc., and 3) Pronet Systems Integrated Network Solution, Inc. purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat from 11 to 25 September 2020;

WHEREAS, the Pre-bid Conference scheduled on 15 September 2020 was attended by two (2) bidders, namely: 1) Solid Business Machines Center, Inc., and 2) American Technologies, Inc.;

WHEREAS, Supplemental/Bid Bulletin No. 06, Series of 2020, clarify or amend some provisions originally indicated in the Section VI. Schedule of Requirements and Section VII. Technical Specifications of the Bidding Documents, were issued to the bidders;

WHEREAS, the submission and opening of bids originally scheduled on 29 September 2020 was moved to 06 October 2020 and was attended by three (3) bidders, namely: 1) Solid Business Machines Center, Inc., 2) Epartners Solutions, Inc., and 3) Pronet Systems Integrated Network Solutions, Inc. Said bidders submitted their technical and financial envelopes. After the preliminary examination, the eligibility and technical requirements of the three (3) bidders were rated as "**passed**". Hence, the BAC - Technical Working Group (BAC-TWG) opened their

financial envelopes which were likewise found to be compliant and recommended for bid evaluation;

WHEREAS, based on the evaluation of the bids conducted by the DOLE BAC Technical Working Group on 08 October 2020, Epartners Solutions, Inc. was declared as the Lowest Calculated Bidder per BAC Resolution No. 097, Series of 2020 for the project “**Supply and Delivery of Four (4) units High Speed Document Scanner (New-Branded)**”;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by **Epartners Solutions, Inc.** its bid has been found to be responsive;

NOW, THEREFORE, We, the members of the DOLE Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare **Epartners Solutions, Inc.** as the Lowest Calculated Responsive Bidder for the project “Supply and Delivery of Four (4) units High Speed Document Scanner (New-Branded)”
- b. To award the “Supply and Delivery of Four (4) units High Speed Document Scanner (New-Branded)” to **Epartners Solutions, Inc.**; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings
