WHEREAS, the said activity is included in the 2020 Annual Procurement Plan of the Department.

WHEREAS, DOLE BAC Resolution No. 075, Series of 2020 Recommending Small Value Procurement as the mode of procurement for the abovementioned project was signed on 10 September 2020;

WHEREAS, DOLE advertised the Request for Price Quotation for the procurement of the above-mentioned project in the Philippine Government E-Procurement System (PhilGEPS), and DOLE website from 11 to 16 September 2020;

WHEREAS, no bidder submitted Bid Proposal on the opening of bids scheduled on 16 September 2020;

WHEREAS, DOLE re-advertised twice the Request for Price Quotation for the procurement of the above-mentioned project in the Philippine Government E-Procurement System (PhilGEPS), and DOLE website from 16 to 21 September 2020 and 22 to 28 September 2020, respectively;

WHEREAS, in response to the advertisement, only Pronet Systems Integrated Network Solutions, Inc., submitted its Bid Proposal on the opening of bids scheduled on 28 September 2020;

WHEREAS, the BAC-TWG recommended Pronet Systems Integrated Network Solutions, Inc., as the Single Calculated Responsive Bidder for the project "Purchase of Six (6) units Smart TV" based on the Abstract of Price Quotations and was declared **responsive** as indicated in the post-qualification report under small value procurement;


