DECLARING VJ GRAPHIC ARTS, INC. AND GILCOR PRINTING PRESS AS THE LOWEST CALCULATED AND RESPONSIVE BIDDERS FOR ITEMS 1 & 2 AND VJ GRAPHIC ARTS, INC. AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR ITEMS 3 & 4 FOR THE BUREAU OF LOCAL EMPLOYMENT'S PROJECT "SUPPLY AND PRINTING OF VARIOUS ADVOCACY MATERIALS FOR FIRST TIME JOBSEEKERS ASSISTANCE ACT (FTJAA) – RE- BIDDING"

WHEREAS, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the abovementioned project with an Approved Budget for the Contract (ABC) of ₱410,900.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE Website and conspicuous places at the DOLE's premises from 18 September 2020 to 13 October 2020;

WHEREAS, said project is included in the Indicative FY 2020 Annual Procurement Plan of the Department;

WHEREAS, in response to the advertisement, two bidders namely: (1) Gilcor Printing Press, and (2) VJ Graphic Arts, Inc. purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat on 24 September 2020 to 29 September 2020;

WHEREAS, the Pre-bid Conference originally scheduled on 29 September 2020 was attended by three bidders namely: (1) Gilcor Printing Press, (2) VJ Graphic Arts, Inc., and (3) Aresa Printing;

WHEREAS, the submission and opening of bids scheduled on 13 October 2020 and was attended by two bidders namely: (1) Gilcor Printing Press, and (2) VJ Graphic Arts, Inc. Said bidders submitted their technical and financial envelopes. After preliminary examination, the technical proposals of Gilcor Printing Press and VJ Graphic Arts, Inc. were rated as "**passed**" hence, the BAC opened the financial envelopes of Gilcor Printing Press and VJ Graphic Arts, Inc. which were also rated as "**passed**";

WHEREAS, based on the foregoing evaluation VJ Graphic Arts, Inc. and Gilcor Printing Press, had the same bid amount for items 1 and 2, ₱210,900.00;

WHEREAS, based on the evaluation of the bids conducted by the DOLE-BAC Technical Working Group, VJ Graphic Arts, Inc. and Gilcor Printing Press complied with the mandatory minimum requirements, which include eligibility and technical documents and financial proposals of the said project be declared as the Lowest Calculated Bidders for items 1 & 2, and VJ Graphic Arts, Inc. be declared as the Lowest Calculated Bidder for items 3 & 4 for the said project "Supply and Printing of Various Advocacy Materials for First Time Jobseekers Assistance Act (FTJAA) – Re-Bidding", which was presented during the BAC meeting on 19 October 2020 per BAC Resolution No. 100, Series of 2020;

WHEREAS, BAC Secretariat sent a letter to VJ Graphic Arts, Inc. and Gilcor Printing Press requesting for submission of post-qualification documents;

WHEREAS, on 23 October 2020, VJ Graphic Arts, Inc. and Gilcor Printing Press submitted additional documents for post-qualification;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by VJ Graphic Arts, Inc. and Gilcor Printing Press their both declared "**Responsive**" for items 1 and 2 and thus, shall be subjected to draw lots or similar method of chance pursuant to Appendix 11 of R.A. 9184, GPPB Circular 06-2005, Tie Breaking Method;

WHEREAS, VJ Graphic Arts, Inc. was declared "**Responsive**" for items 3 and 4 for the project "**Supply and Printing of Various Advocacy Materials for First Time Jobseekers Assistance Act (FTJAA) – Re-Bidding**";

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare **VJ Graphic Arts, Inc. and Gilcor Printing Press** as the **Lowest Calculated and Responsive Bidders** for items 1 and 2 and thus, shall be subjected to draw lots or similar method of chance pursuant to Appendix 11 of R.A. 9184, GPPB Circular 06-2005, Tie Breaking Method;
- b. To declare **VJ Graphic Arts, Inc.** as the **Lowest Calculated and Responsive Bidder** for items 3 & 4 of the Bureau of Local Employment's project "**Supply and Printing of Various Advocacy Materials for First Time Jobseekers Assistance Act (FTJAA) – Re-Bidding**";
- c. To award the procurement of the project "**Supply and Printing of Various Advocacy Materials for First Time Jobseekers Assistance Act (FTJAA) – Re-Bidding**"; for the Bureau of Local Employment to **VJ Graphic Arts, Inc.** on items 3 & 4; and
- d. To recommend for approval by the DOLE Undersecretary the foregoing findings.


