**DECLARING TOYOTA BALINTAWAK INC. AS THE SINGLE
CALCULATED RESPONSIVE BIDDER FOR THE ADMINISTRATIVE
SERVICE'S PROJECT "SUPPLY AND DELIVERY OF ONE (1) BRAND NEW
SERVICE VEHICLE FOR THE DEPARTMENT OF LABOR AND EMPLOYMENT –
CENTRAL OFFICE"**

WHEREAS, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the abovementioned project with an Approved Budget for the Contract (ABC) of ₱1,350,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE Website and conspicuous places at the DOLE's premises from 19 August 2020 to 08 September 2020;

WHEREAS, said project is included in the Indicative FY 2020 Annual Procurement Plan of the Department;

WHEREAS, in response to the advertisement, Toyota Balintawak Inc. purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat on 08 September 2020;

WHEREAS, Notice of Postponement was issued on the Pre-bid Conference originally scheduled on 25 August 2020 and has been moved to 28 August 2020;

WHEREAS, Supplemental Bid Bulletin No. 04 was issued to amend and clarify some provisions originally indicated in the Bidding Documents;

WHEREAS, the submission and opening of bids scheduled on 08 September 2020 and likewise moved on 10 September 2020 was attended by lone bidder, Toyota Balintawak Inc. Said bidder submitted its technical and financial envelopes. After preliminary examination, the technical proposals of Toyota Balintawak Inc. were rated as "passed" hence, the BAC opened its financial envelopes which were also rated as "passed";

WHEREAS, the BAC - TWG in its bid evaluation report dated 15 September 2020 as duly concurred by the members of the BAC, examined and evaluated the bid proposal of Toyota Balintawak Inc.;

WHEREAS, based on the evaluation of the bids conducted by the DOLE-BAC Technical Working Group, Toyota Balintawak Inc. complied with the mandatory minimum specifications of the said project which was presented during the BAC meeting on 15 September 2020, was declared as the Single Calculated Bidder per BAC Resolution No. 081, Series of 2020;

WHEREAS, BAC Secretariat sent a letter to Toyota Balintawak Inc. requesting for submission of post-qualification documents;

WHEREAS, on 17 September 2020, Toyota Balintawak Inc. submitted additional documents for post-qualification;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Toyota Balintawak Inc., its bid has been found to be responsive;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare **Toyota Balintawak Inc.** as the **Single Calculated Responsive Bidder** for the Administrative Service's project "**Supply and Delivery of One (1) Brand New Service Vehicle for the Department of Labor and Employment-Central Office**";
- b. To award the "**Supply and Delivery of One (1) Brand New Service Vehicle for the Department of Labor and Employment-Central Office**" for the Administrative Service's project to **Toyota Balintawak Inc.**; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.
