CONTRACT AGREEMENT

THIS AGREEMENT, made this ____ day of 28 OCT 2020, 2020 by and between the **DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE)**, with office address at DOLE Main Building, Intramuros, Manila, represented by **Undersecretary RENATO L. EBARLE**, hereinafter called the “**DOLE**” and **TOYOTA BALINTAWAK, INC.** with office address at Edsa cor. V. Ang an General Evangelista St. Caloocan City represented by its Marketing Professional, **MR. JOSEPH N. CACAYURAN**, hereinafter called the “**Service Provider**”.

WHEREAS, the **DOLE** invited Bids for certain goods and ancillary services, viz., for **Supply and Delivery of One (1) Brand New Service Vehicle for the Department of Labor and Employment-Central Office of the Administrative Service’s project** and the **DOLE** has accepted a total Bid for **One Million Three Hundred Forty-Eight Thousand Pesos only (₱1,348,000.00)** hereinafter called the “**Contract Price**”.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of the Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Purchase Request;
 - b. Terms of Reference;
 - c. Schedule of Requirements;
 - d. Technical Specifications;
 - e. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents / statements submitted;
 - f. Instructions to Bidders;
 - g. Bid Data Sheet;
 - h. General Conditions of Contract;
 - i. Special Conditions of Contract;
 - j. Notice of Award of Contract and Bidder’s conforme thereto; and
 - k. Performance Security;
3. Likewise, the Revised Implementing Rules and Regulations of Republic Act No. 9184 shall apply in the implementation of the project.

4. In consideration of the payments to be made by the **DOLE** to the **Service Provider** as hereinafter mentioned, the **Service Provider** hereby covenants with the **DOLE** to provide the goods and services and to remedy defects therein in conformity with the provisions of the Contract in all respects.
5. The **DOLE** hereby covenants to pay the **Service Provider** in consideration of the provisions of the goods and services and remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of this **Contract** at the time and in the manner prescribed by this **Contract**.

IN WITNESS whereof the parties thereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.




