**DECLARING NATIONAL PRINTING OFFICE (NPO) AS THE LOWEST  
 RECOGNIZED GOVERNMENT PRINTER (RGP) FOR THE PRINTING OF  
 ALIEN EMPLOYMENT PERMIT (AEP) CARDS**

**WHEREAS**, the Department of Labor and Employment (DOLE), through the Bureau of Local Employment (BLE), requisitioned for the printing of 214,285 pieces of Alien Employment Permit (AEP) cards for distribution to all DOLE Regional Offices with an Approved Budget for the Contract of Five Million Nine Hundred Ninety Nine Thousand Nine Hundred Eighty Pesos (₱5,999,980.00);

**WHEREAS**, the said project is included in the 2020 Annual Procurement Plan of the Department.

**WHEREAS**, AEP cards is considered as one of the accountable forms of DOLE;

**WHEREAS**, Bids and Awards Committee (BAC) instructed the end-user to include other Recognized Government Printers (RGP) in the market study during the BAC Meeting on 6 August 2020;

**WHEREAS**, BLE requested via email the Bangko Sentral ng Pilipinas (BSP), and APO Production Unit for their price quotations, while NPO requested through phone call on 12 August 2020;

**WHEREAS**, BAC Resolution No. 59, Series of 2020 recommending Negotiated Procurement through Agency to Agency as the Method of Procurement for the abovementioned project was approved on 19 August 2020;

**WHEREAS**, in response to the request, two (2) printers, namely: 1) Apo Production Unit, and 2) National Printing Office submitted their bid proposals at ₱26.00 and ₱25.00 per piece on 27 and 28 August 2020, respectively;

**WHEREAS**, the BAC-TWG recommended National Printing Office as the Lowest Recognized Government Printer for the project "Printing of Alien Employment Permit (AEP) Cards based on the Abstract of Price Quotations;

**NOW, THEREFORE,** We, the members of the DOLE Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare **National Printing Office** as the Lowest Recognized Government Printer for the project "**Printing of Alien Employment Permit (AEP) Cards**";
- b. To engage the services of the National Printing Office for the Printing of 214,285 pieces of Alien Employment Permit (AEP) Cards in the amount of Five Million Three Hundred Fifty Seven Thousand One Hundred Twenty Five Pesos (P5,357,125.00); and
- c. To recommend for approval by the Honorable Secretary the foregoing findings.


