## CONTRACT AGREEMENT

15 DEC 2020

THIS AGREEMENT, made this \_\_\_\_ day of \_\_\_\_\_, 2020 between the **DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE)**, with office address at DOLE Main Building, Intramuros, Manila, represented by **Undersecretary RENATO L. EBARLE**, hereinafter called the "**DOLE**" and **EPARTNERS SOLUTIONS, INC.** with office address at Unit 2506 Prestige Tower, F. Ortigas Jr. Road, Ortigas Center, Pasig City, represented by its Account Executive, **MS. SUSAN L. SANCHEZ**, hereinafter called the "**Supplier**".

**WHEREAS**, the **DOLE** invited Bids for certain goods and ancillary services, viz., **Supply and Delivery of Four (4) units High Speed Document Scanner (New - Branded)** and the **DOLE** has accepted a total Bid for **Two Hundred Ninety Six Thousand Three Hundred Sixty Four Pesos Only (P296,364.00)**, hereinafter called the "**Contract Price**".

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - a) Purchase Request;
  - b) Winning bidder's bid, including the eligibility requirements, Technical and Financial proposals, and all other documents/statements submitted;
  - c) Schedule of Requirements;
  - d) Technical Specifications;
  - e) General Conditions of Contract;
  - f) Special Conditions of Contract;
  - g) Performance Security;
  - h) Entity's Notice of Award; and
  - i) Purchase Order
3. Likewise, the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall apply in the implementation of the project.

4. In consideration of the payments to be made by the **DOLE** to the **Supplier** as hereinafter mentioned, the **Supplier** hereby covenants with the **DOLE** to provide the goods and services and to remedy any defects therein in conformity with the provisions of the Contract in all respects.
5. The **DOLE** hereby covenants to pay the **Supplier** in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of this **Contract** at the time and in the manner prescribed by this **Contract**.

**IN WITNESS** whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


