**DECLARING SECOND FAILURE OF BIDDING FOR LOTS 1, 2, AND 5 OF
THE PROJECT "SUPPLY AND DELIVERY OF VARIOUS ICT EQUIPMENT AND
PERIPHERALS FOR DOLE VIDEO CONFERENCES AND OFFICE
PRODUCTIVITY"- RE-BIDDING**

WHEREAS, BAC Resolution No. 156, Series of 2020 was issued declaring a failure of bidding for Lots 1, 2 and 5 for the abovementioned project because the bidder was declared ineligible. The BAC Resolution was approved on December 23, 2020;

WHEREAS, the DOLE re-advertised the Invitation to Bid for the abovementioned project with an Approved Budget for the Contract (ABC) of ₱686,505.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE website, and conspicuous places at the DOLE's premises from December 24, 2020 to January 19, 2021;

WHEREAS, no prospective bidder responded to the advertisement and purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat;

WHEREAS, the Pre-bid Conference scheduled on 05 January 2021 was attended by two (2) bidders, namely: 1) Pronet Systems Integrated Network Solution, Inc., and 2) The Brain Computer Corp.;

WHEREAS, on the Submission and Opening of Bids scheduled on 19 January 2021 no prospective bidder attended and submitted their technical and financial envelopes;


NOW, THEREFORE, for and in consideration of the foregoing, we, the members of the Bids and Awards Committee, by virtue of the powers vested on us by law, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare the bidding a "failure" for the second time since no prospective bidder purchased/submitted bids for the project;
- b. To recommend a mandatory review and revision of the purchase request and technical specifications;
- c. To recommend that a Negotiated Procurement through two-failed biddings be conducted; and
- d. To recommend for the approval by the DOLE Undersecretary the foregoing findings.




