DECLARING THE COMPETITIVE BIDDING FOR THE PROJECT "PROVISION OF JANITORIAL SERVICES FOR A PERIOD OF ONE (1) YEAR IN THE DOLE CENTRAL OFFICE" A FAILURE

WHEREAS, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the above-mentioned project with an Approved Budget for the Contract (ABC) of ₱12,467,619.38 in the Philippine Government E-Procurement System (PhilGEPS), DOLE website, and conspicuous places at the DOLE's premises from 13 November 2020 to 01 December 2020;

WHEREAS, said project is included in the approved Fiscal Year (FY) 2021 Indicative Annual Procurement Plan of the Department;

WHEREAS, the Pre-bid Conference originally scheduled on 19 November 2020 has been moved to 24 November 2020 and was attended only by Mansion Maintenance Company, Incorporated;

WHEREAS, in response to the advertisement, only Mansion Maintenance Company, Incorporated purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat on 01 December 2020;

WHEREAS, the submission and opening of bids originally scheduled on 01 December 2020 has been moved to 09 December 2020, was attended only by Mansion Maintenance Company, Incorporated. Said bidder submitted its technical and financial envelopes. After the preliminary examination, the eligibility and technical requirements of the bidder was rated as "**passed**". Hence, the BAC - Technical Working Group (BAC-TWG) opened the financial envelopes which was likewise found to be compliant and recommended for bid evaluation;

WHEREAS, based on the evaluation of the bids conducted by the DOLE BAC Technical Working Group on 10 December 2020, Mansion Maintenance Company, Incorporated was declared as the Single Calculated Bidder per BAC Resolution No.

137, Series of 2020 for the project “**Provision of Janitorial Services for a Period of One (1) Year in the DOLE Central Office**”;

WHEREAS, the BAC Secretariat sent a letter dated 10 December 2020 to Mansion Maintenance Company, Incorporated requesting for submission of post-qualification documents;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Mansion Maintenance Company, Incorporated it was found out that the bid failed to comply with and be responsive to the requirements and conditions specified in the bidding documents for said project due to non-submission of its **Certificate of PhilGEPS Registration on time**;

NOW, THEREFORE, for and in consideration of the foregoing, we, the members of the DOLE Bids and Awards Committee, by virtue of the powers vested on us by law, hereby **RESOLVE** as it is hereby **RESOLVED**:


- a. To post-disqualify Mansion Maintenance Company, Incorporated due to non-submission of its **Certificate of PhilGEPS Registration on time**;
- b. To declare the competitive bidding a “failure” in view of the post-qualification of the bidder;
- c. To recommend that a re-bidding be conducted; and
- d. To recommend for approval by the DOLE Undersecretary the foregoing findings.

RESOLVED, at the DOLE Main Building, Intramuros, Manila, this 5th day of January 2021.


