**DECLARING GILCOR PRINTING PRESS AS THE LOWEST  
CALCULATED RESPONSIVE BIDDER FOR THE PROJECT "PRINTING  
OF 20<sup>TH</sup> PESO MILESTONE COFFEE TABLE BOOK"**

**WHEREAS**, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the above-mentioned project with an Approved Budget for the Contract (ABC) of ₱500,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE website, and conspicuous places at the DOLE's premises from 02 September to 29 September 2020;

**WHEREAS**, said project is included in the approved 2020 Annual Procurement Plan of the Department;

**WHEREAS**, in response to the advertisement, four (4) prospective bidders, namely: 1) Key Printing Press Corp., 2) VJ Graphic Arts, Inc., 3) Gilcor Printing Press, and 4) Zurbano Publishing & Printing Corporation purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat from 16 September to 28 September 2020;

**WHEREAS**, two (2) bidders, namely: 1) Zurbano Publishing & Printing Corporation, and 2) Key Printing Press Corp. attended the Pre-bid Conference scheduled on 10 September 2020;

**WHEREAS**, Supplemental /Bid Bulletin No. 06, Series of 2020 to clarify or amend some provisions originally indicated in the Bidding Documents specifically on the Section VI. Schedule of Requirement and Section VII. Technical Specifications was issued to the bidders;

**WHEREAS**, the submission and opening of bids originally scheduled on 22 September 2020 has been moved to 29 September 2020, was attended by three (3) bidders, namely: 1) Zurbano Publishing & Printing Corporation, 2) Gilcor Printing Press and 3) VJ Graphic Arts, Inc. Said bidders submitted their technical and financial envelopes. After the preliminary examination, the eligibility and technical requirements of the two (2) bidders were rated as "**passed**". Hence, the BAC - Technical Working Group (BAC-TWG) opened the financial envelopes which were likewise found to be compliant and recommended for bid evaluation;

**WHEREAS**, based on the evaluation of the bids conducted by the DOLE BAC Technical Working Group on 30 September 2020, **Gilcor Printing Press** was declared as the Lowest Calculated Bidder per BAC Resolution No. 093, Series of 2020 for the project "*Printing of 20<sup>th</sup> PESO Milestone Coffee Table Book*";

**WHEREAS**, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Gilcor Printing Press, its bid has been found to be responsive;

**NOW, THEREFORE**, We, the members of the DOLE Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare **Gilcor Printing Press** as the Lowest Calculated Responsive Bidder for the project "*Printing of 20<sup>th</sup> PESO Milestone Coffee Table Book*";
- b. To award the project "*Printing of 20<sup>th</sup> PESO Milestone Coffee Table Book*" to **Gilcor Printing Press**; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.
