WHEREAS, the Department of Labor and Employment (DOLE), through the Bureau of Workers with Special Concerns (BWSC), requisitioned the "Printing of Various Information, Education and Communication Materials" with a total Approved Budget for the Contract of ₱277,500.00;

WHEREAS, the said activity is included in the 2020 Annual Procurement Plan of the Department.

WHEREAS, DOLE BAC Resolution No. 125, Series of 2020 Recommending Small Value Procurement as the mode of procurement for the abovementioned project was signed on 26 November 2020;

WHEREAS, DOLE advertised the Request for Price Quotation for the procurement of the above-mentioned project in the Transparency Seal of the DOLE Website from 27 November 2020 to 02 December 2020;

WHEREAS, in response to the advertisement, two (2) bidders, namely: 1) Zurbano Publishing & Printing Corporation, and 2) VJ Graphic Arts, Inc. submitted their Bid Proposals on the opening of bids scheduled on 02 December 2020;

WHEREAS, the BAC-TWG recommended Zurbano Publishing & Printing Corporation as the Lowest Calculated Responsive Bidder for the project "**Printing of Information, Education and Communication (IEC) Materials**" based on the Abstract of Price Quotations and was declared **responsive** as indicated in the post-qualification report under small value procurement;




