**DECLARING POWER HOUSE PEST CONTROL SERVICES AS THE
LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE ADMINISTRATIVE
SERVICE'S PROJECT "PROVISION OF TERMITE CONTROL AND PEST CONTROL
SERVICES OF THE DOLE-CENTRAL OFFICE FOR A PERIOD OF ONE (1) YEAR"**

WHEREAS, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the abovementioned project with an Approved Budget for the Contract (ABC) of ₱372,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE Website and conspicuous places at the DOLE's premises from 30 October 2020 to 24 November 2020;

WHEREAS, said project is included in the Indicative FY 2021 Indicative Annual Procurement Plan of the Department;

WHEREAS, in response to the advertisement, three bidders namely: (1) Power House Pest Control Services, (2) Pest Terminators and (3) D-Three Pest Management Services purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat from 11 November 2020 to 18 November 2020;

WHEREAS, the Pre-bid Conference scheduled on 10 November 2020 was attended by three bidders namely: (1) Power House Pest Control Services, (2) Pest Terminators and (3) D-Three Pest Management Services;

WHEREAS, the submission and opening of bids scheduled on 24 November 2020 was attended by two bidders namely: (1) Power House Pest Control Services, and (2) D-Three Pest Management Services. Said bidders submitted their technical and financial envelopes. After preliminary examination, the technical proposals of Power House Pest Control Services, and D-Three Pest Management Services were rated as "**passed**" hence, the BAC opened the financial envelopes of Power House Pest Control Services, and D-Three Pest Management Services which were also rated as "**passed**";

WHEREAS, D-Three Pest Management Services sent a letter dated 24 November 2020 requesting clarification relative to their observation during the Opening of Bids that the other bidder Power House Pest Control Services failed to submit the Terms of Reference for the project;

WHEREAS, the DOLE Bids and Awards Committee sent letter reply to D-Three Pest Management Services on 26 November 2020 informing them that submission of Terms and Reference (TOR) is not included in Section VIII – Checklist of Technical and Financial Documents provided in the Philippine Bidding Document for the project;

WHEREAS, based on the evaluation of the bids conducted by the DOLE-BAC Technical Working Group, Power House Pest Control Services complied with the mandatory minimum specifications of the said project which was presented during the BAC meeting on 26 November 2020, Power House Pest Control Services was declared as the Lowest Calculated Bidder per BAC Resolution No. 126, Series of 2020;

WHEREAS, BAC Secretariat sent a letter to Power House Pest Control Services requesting for submission of post-qualification documents;

WHEREAS, on 02 December 2020, Power House Pest Control Services submitted additional documents for post-qualification;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Power House Pest Control Services, its bid has been found to be responsive;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:


- a. To declare **Power House Pest Control Services** as the Lowest Calculated and Responsive Bidder for the **Administrative Service's** project "**Provision of Termite Control and Pest Control Services of the DOLE-Central Office for a Period of One (1) Year**";
- b. To award the project "**Provision of Termite Control and Pest Control Services of the DOLE-Central Office for a Period of One (1) Year**" for the **Administrative Service's** project to **Power House Pest Control Services**; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.


