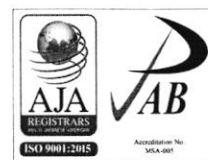

CONTRACT AGREEMENT

THIS AGREEMENT, made this ____ day of 22 JAN 2021, 2021 by and between the **DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE)**, with office address at DOLE Main Building, Intramuros, Manila, represented by **Secretary SILVESTRE H. BELLO III**, hereinafter called the “**DOLE**” and **TOYOTA BALINTAWAK, INC.** with office address at Edsa cor. V. Ang and General Evangelista St. Caloocan City represented by its Marketing Professional, **MR. JOSEPH N. CACAYURAN**, hereinafter called the “**Service Provider**”.

WHEREAS, the **DOLE** invited Bids for certain goods and ancillary services, viz., of the “**Supply and Delivery of Two (2) Brand New Service Vehicles for the Department of Labor and Employment-Central Office**” for the **Administrative Service’s project** and the **DOLE** has accepted a total Bid of **Two Million Five Hundred Ninety-Eight Thousand Pesos only (₱2,598,000.00)** hereinafter called the “**Contract Price**”.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of the Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications and Terms of Reference;
 - iii. General Conditions of Contract;
 - iv. Special Conditions of Contract;
 - b. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents / statements submitted;

Bid form including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarification on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;
 - c. Notice of Award of Contract and Bidder’s conforme thereto;
 - d. Performance Security;
 - e. Purchase Order; and

- f. Other Contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. The supplier agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice To Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 4. In consideration for the sum of **Two Million Five Hundred Ninety-Eight Thousand Pesos (₱2,598,000.00)** or such other sums as may be ascertained, the Supplier agrees to provide **Supply and Delivery of Two (2) Brand New Service Vehicles for the Department of Labor and Employment-Central Office** in accordance with its Bid.
- 5. The **DOLE** agrees to pay the above-mentioned sum in accordance with the terms of the bidding.

IN WITNESS whereof the parties thereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


