CONTRACT AGREEMENT

THIS AGREEMENT, made this JAN 25 2021 day of _____, 2020 between the **DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE)**, with office address at DOLE Main Building, General Luna corner Muralla Streets, Intramuros, Manila, represented by **Undersecretary RENATO L. EBARLE**, hereinafter called the "**DOLE**" and **BSI GROUP PHILIPPINES, INC.** with office address at Unit 2408, The Orient Square F. Ortigas Jr. Road, Ortigas Business Center, Pasig City, Metro Manila represented by its Senior Business Development Manager, **MS. RANI M. CANILLAS** hereinafter called the "**Service Provider**".

WHEREAS, the DOLE invited Bids for certain goods and ancillary services, particularly "Services of a Training Institution/provider for the conduct of ISO 9001:2015 Training Courses via Online Platform", and the DOLE has accepted a total Bid for **Three Hundred Fifty Nine Thousand Four Hundred Eight Pesos Only (P359,408.00)**, hereinafter called the "**Contract Price**".

 - c) Performance Security;
 - d) Notice of Award of Contract; and the Bidder's conforme thereto; and
 - e) Notice to Proceed
3. In consideration for the sum of **Three Hundred Fifty Nine Thousand Four Hundred Eight Pesos (P359,408.00)** or such other sums as may be ascertained, BSI Group Philippines, Inc. agrees to provide services of a training institution/provider for the conduct of ISO 9001: 2015 training courses via online platform in accordance with her Bid.


