**SERVICE AGREEMENT**

**KNOW ALL MEN BY THESE PRESENTS:**

This **AGREEMENT** entered into this \_\_\_\_\_ day of DEC 29 2020, by and between:

**The DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE)**, a government agency mandated to formulate policies, implement programs and services, and serve as the policy-coordinating arm of the Executive Branch in the field of labor and employment, tasked with the enforcement of the provisions of the Labor Code, that sets the rules for the hiring and firing of private employees, work conditions, employee benefits, and the guidelines in the organization and membership in labor unions and collective bargaining, with office address at General Luna corner Muralla Streets, Intramuros, herein represented by its Secretary, hereinafter referred to as **DOLE**,

and

**TELENETWORK MEDIA CENTER, INC.** a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with office address at Unit 908 Cityland Herrera Tower, V.A. Rufino corner Herrera Streets, Salcedo Village, Makati City, Philippines, herein represented by its President, hereinafter referred to as "**MEDIA PROVIDER**".

**WITNESSETH:**

**WHEREAS**, DOLE is in need of the services of a media outfit for the production of a quality television cum radio (teleradyo) program, as well as social media pages that are heard and seen across the country, which will discuss weekly issues on labor and employment and other related concerns;

**WHEREAS**, DOLE Administrative Order No. 167, series of 2017 directs all offices and attached agencies of the department, including the POLOs to take urgent and aggressive action in communicating their respective mandates through regular good news releases that will create a favorable environment and hasten the country's recovery from the economic hot brought by the Covid-19 pandemic;

**WHREAS**, both parties agreed to perform the following:

**DOLE** will:

Ensure that the duration stipulated in the agreement shall be fulfilled for one year, equivalent to fifty (52) weeks/episodes that will commence on **January 2** until

**December 25, 2021**, warranting non-cancellation or pre-termination of the program, unless otherwise provided by law.

2. Provide Media Provider/Supplier the following:

- 2.1 Notice to Proceed;
- 2.2 Notice of Award;
- 2.3 Bids and Awards Committee (BAC) Resolution; and
- 2.4 Certificate of Availability of Funds

3. Pay Media Provider, in consideration of the services, it will undertake in accordance with the Technical Specifications, Scope of Work, Terms of Reference, and/or Purchase Request relevant for this project.

4. Assign a support staff who will act as the conduit between DOLE and the Media Provider, acting on certain issues that are necessary for the Entity to get the quality of service expected from the Media Provider.

**MEDIA PROVIDER/SUPPLIER TELENETWORK MEDIA CENTER, INC.** will:

- 1. Provide airtime for a one-hour program for one year equivalent to 52 weeks or episodes from a mass-based television/radio station that commands wide viewership/listenership-base across the country, with wide international audience reach, and can simulcast on the UHF television channels and digital platforms, such as but not limited to Facebook Youtube, Tweeter, link in the station's website, etc.;

However, as per standard policy of DZBB/GMA News TV and other broadcast stations, they have the right to cancel the program among the following grounds: If the program content is against the policy of the station; If the program is being used as a tool for political purposes/gains,; If the program does not rate. Should this happen, the Media provider shall look for another top-rating radio station with teleradyo component as replacement for the unaired weeks based on the stipulation of this contract.

Furthermore, our carrying station (DZBB/GNTV) also has the right to pre-empt our episode should there be an important event or national issue that may coincide during our assigned airing time. The station however, will give a make-up, or replace our airing time with another airing schedule. An advance notice will be given prior to the pre-emption of the program for a specific airing schedule.
