CONTRACT AGREEMENT

21 DEC 2020

THIS AGREEMENT, made this ____ day of _____, 2020 between the **DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE)**, with office address at DOLE Main Building, Intramuros, Manila, represented by **Undersecretary RENATO L. EBARLE**, hereinafter called the "**DOLE**" and **GILCOR PRINTING PRESS** with office address at #15 San Ponciano Street, San Antonio Homes, Brgy. Culiati, Quezon City, represented by its Owner **MS. MA. CONCEPCION P. MARAMBA**, hereinafter called the "**Supplier**".

WHEREAS, the **DOLE** invited Bids for certain goods and ancillary services, viz., **Printing of 20th PESO Milestone Coffee Table Book** and the **DOLE** has accepted a total Bid for **One Hundred Ninety Eight Thousand Six Hundred Pesos Only (₱198,600.00)**, hereinafter called the "**Contract Price**".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a) Purchase Request;
 - b) Winning bidder's bid, including the eligibility requirements, Technical and Financial proposals, and all other documents/statements submitted;
 - c) Schedule of Requirements;
 - d) Technical Specifications;
 - e) General Conditions of Contract;
 - f) Special Conditions of Contract;
 - g) Performance Security;
 - h) Entity's Notice of Award; and
 - i) Job Order
3. Likewise, the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall apply in the implementation of the project.
4. In consideration of the payments to be made by the **DOLE** to the **Supplier** as hereinafter mentioned, the **Supplier** hereby

covenants with the **DOLE** to provide the goods and services and to remedy any defects therein in conformity with the provisions of the Contract in all respects.

5. The **DOLE** hereby covenants to pay the **Supplier** in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of this **Contract** at the time and in the manner prescribed by this **Contract**.
