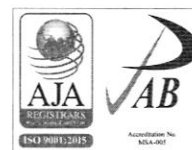

DECLARING PRONET SYSTEMS INTEGRATED NETWORK SOLUTION, INC. AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE SUPPLY AND DELIVERY OF LOT 1 (PORTABLE HANDHELD DEVICE PACKAGED) OF THE INFORMATION AND PUBLICATION SERVICE'S PROJECT "SUPPLY AND DELIVERY OF VARIOUS VIDEO EQUIPMENT AND PURCHASE OF BROADCASTING SOFTWARE FOR LIVE STREAMING OF DOLE EVENTS AND ACTIVITIES ON ONLINE MEDIA"

WHEREAS, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the abovementioned project with an Approved Budget for the Contract (ABC) of ₱515,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE Website and conspicuous places at the DOLE's premises from 16 November 2020 to 08 December 2020;

WHEREAS, said project is included in the FY 2020 Annual Procurement Plan of the Department;

WHEREAS, no prospective bidder attended on the Pre-bid Conference scheduled 24 November 2020;

WHEREAS, in response to the advertisement, lone bidder, Pronet Systems Integrated Network Solution, Inc. purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat from 09 December 2020;

WHEREAS, the submission and opening of bids scheduled on 08 December 2020 and likewise moved on 09 December 2020 was attended by lone bidder, Pronet Systems Integrated Network Solution, Inc. Said bidder submitted its technical and financial envelopes. After opening its technical proposals and conduct of preliminary examination, Pronet Systems Integrated Network Solution, Inc. was rated as **"passed"** hence, the BAC opened its financial envelope which was also rated as **"passed"**;

WHEREAS, the BAC - TWG in its bid evaluation report dated 10 December 2020 as duly concurred by the members of the BAC, examined and evaluated the bid proposal of Pronet Systems Integrated Network Solution, Inc.;

WHEREAS, based on the evaluation of the bids conducted by the DOLE-BAC Technical Working Group, Pronet Systems Integrated Network Solution, Inc. complied

with the mandatory minimum specifications of the said project which was presented during the BAC meeting on 10 December 2020 Pronet Systems Integrated Network Solution, Inc. was declared as the Single Calculated Bidder per BAC Resolution No. 140, Series of 2020;

WHEREAS, BAC Secretariat sent a letter to Pronet Systems Integrated Network Solution, Inc. requesting for submission of post-qualification documents;

WHEREAS, on 14 December 2020, Pronet Systems Integrated Network Solution, Inc. submitted additional documents for post-qualification;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Pronet Systems Integrated Network Solution, Inc., its bid has been found to be responsive;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare **Pronet Systems Integrated Network Solution, Inc.** as the **Single Calculated and Responsive Bidder** for the Supply and Delivery of Lot 1 (Portable Handheld Device Package) of the **Information and Publication Service's** project **"Supply and Delivery of Various Video Equipment and Purchase of Broadcasting Software for Live Streaming of DOLE Events and Activities on Online Media"**;
- b. To award the project **"Supply and Delivery of Various Video Equipment and Purchase of Broadcasting Software for Live Streaming of DOLE Events and Activities on Online Media"** for the Supply and Delivery of Lot 1 (Portable Handheld Device Package) of the **Information and Publication Service's** project to **Pronet Systems Integrated Network Solution, Inc.**; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.

RESOLVED, at the DOLE Building, Intramuros, Manila, this 17th day of December 2020.


