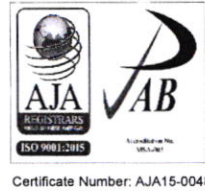

**CONTRACT AGREEMENT**

THIS AGREEMENT, made this 16 FEB 2021 day of \_\_\_\_\_, 2021 between the **DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE)**, with office address at DOLE Main Building, Muralla Wing cor. General Luna Street, Intramuros, Manila, represented by **UNDERSECRETARY RENATO L. EBARLE**, hereinafter called the “**DOLE**” and **PRONET SYSTEMS INTEGRATED NETWORK SOLUTION, INC.** with office address at 3<sup>rd</sup> Floor, Hollywood Square Building, #33 West Avenue, Brgy. Nayong Kanluran, Quezon City represented by its Senior Sales Engineer, **MS. HAZEL JOY D.T. LACDO-O**, hereinafter called the “**SUPPLIER**”.

**WHEREAS**, the DOLE invited Bids for certain goods and ancillary services, viz., “**Subscription of License Renewal for Fortigate 200D for One (1) Year of the Planning Service**” and the DOLE has accepted a Bid for **Two Hundred Thousand Pesos only (P200,000.00)** hereinafter called the “Contract Price”.

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications; and
    - iii. General and Special Conditions of Contract;
  - ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;  
  
Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;
  - iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder’s conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **Two Hundred Thousand Pesos (P200,000.00)** or such other sums as may be ascertained, **Pronet Systems Integrated Network Solution, Inc.** agrees to provide **Subscription of License Renewal for Fortigate 200D for One (1) Year of the Planning Service** in accordance with his/her/its Bid.
4. The DOLE agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.






