**DECLARING PISHON INDUSTRIES, INCORPORATED AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE RE-BIDDING OF THE PROJECT “SUPPLY AND DELIVERY OF FIVE (5) GALLON PURIFIED DRINKING WATER FOR OFFICIALS AND EMPLOYEES OF THE DOLE – CENTRAL OFFICE FOR A PERIOD OF ONE (1) YEAR”**

**WHEREAS**, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the re-bidding of the abovementioned project with an Approved Budget for the Contract (ABC) of ₱600,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE Website and conspicuous places at the DOLE’s premises from 19 January 2021 to 09 February 2021;

**WHEREAS**, said project is included in the approved FY 2021 Annual Procurement Plan of the Department;

**WHEREAS**, in response to the advertisement, only Pishon Industries, Incorporated purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat;

**WHEREAS**, the Pre-bid Conference scheduled on 26 January 2021 was attended only by Pishon Industries, Incorporated;

**WHEREAS**, during the submission and opening of bids on 09 February 2021, Pishon Industries, Incorporated submitted its technical and financial envelopes. Upon eligibility check, the technical component of the lone bidder was rated as “**passed**”. Hence, the BAC-Technical Working Group (TWG) opened the financial envelope which was likewise found to be compliant and recommended for bid evaluation. The BAC approved the TWG’s recommendation and instructed the TWG to conduct immediate bid evaluation;

**WHEREAS**, based on the evaluation of the bids conducted by the DOLE-BAC TWG, Pishon Industries, Incorporated was declared as the Single Calculated Bidder per BAC Resolution No. 024, Series of 2021;

**WHEREAS**, the BAC Secretariat sent a notice to Pishon Industries, Incorporated requesting for submission of post-qualification documents;

**WHEREAS**, on 15 February 2021, Pishon Industries, Incorporated submitted their post-qualification documents;

**WHEREAS**, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Pishon Industries, Incorporated, its bid has been found to be responsive;


**NOW, THEREFORE, We**, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

1. To declare **Pishon Industries, Incorporated** as the Single Calculated and Responsive Bidder for the re-bidding of the project “**Supply and Delivery of Five (5) Gallon Purified Drinking Water for Officials and Employees of the DOLE – Central Office for a Period of One (1) Year**”;
2. To award the project “**Supply and Delivery of Five (5) Gallon Purified Drinking Water for Officials and Employees of the DOLE – Central Office for a Period of One (1) Year**” to **Pishon Industries, Incorporated** at a contract price of **₱600,000.00**; and
3. To recommend for approval by the DOLE Undersecretary the foregoing findings.




