## CONTRACT AGREEMENT

THIS AGREEMENT, made this JUL 09 2020 day of \_\_\_\_\_, 2020 between the **DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE)**, with office address at DOLE Main Building, Intramuros, Manila, represented by **Undersecretary RENATO L. EBARLE**, hereinafter called the “**DOLE**” and **EASTERN TELECOMMUNICATIONS PHILIPPINES, INC.** with office address at Telecom Plaza, 316 Sen. Gil J. Puyat Avenue, Salcedo Village, Makati City, represented by its Account Manager, **MR. ROY E. DIMACULANGAN**, hereinafter called the “**Service Provider**”.

**WHEREAS**, the **DOLE** invited Bids for certain goods and ancillary services, viz., **Subscription of 150 Mbps Internet Leased Line Connection (Primary) for One (1) Year** and the **DOLE** has accepted a total Bid for **One Million Sixty One Thousand Seven Hundred Sixty Pesos Only (P1,061,760.00)**, hereinafter called the “**Contract Price**”.

### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - a) Purchase Request;
  - b) Terms of Reference;
  - c) Winning bidder's bid, including the eligibility requirements, Technical and Financial proposals, and all other documents/statements submitted;
  - d) Schedule of Requirements;
  - e) Technical Specifications;
  - f) General Conditions of Contract;
  - g) Special Conditions of Contract;
  - h) Performance Security; and
  - i) Entity's Notice of Award;
3. Likewise, the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 shall apply in the implementation of the project.

4. In consideration of the payments to be made by the **DOLE** to the **Service Provider** as hereinafter mentioned, the **Service Provider** hereby covenants with the **DOLE** to provide the goods and services and to remedy any defects therein in conformity with the provisions of the Contract in all respects.
5. The **DOLE** hereby covenants to pay the **Service Provider** in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of this **Contract** at the time and in the manner prescribed by this **Contract**.
