CONTRACT AGREEMENT

THIS AGREEMENT, made this MAR 12 2021 day of _____, 2021 between the **DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE)**, with office address at DOLE Main Building, Muralla Wing cor. General Luna Street, Intramuros, Manila, represented by **UNDERSECRETARY RENATO L. EBARLE**, hereinafter called the “**DOLE**” and **PISHON INDUSTRIES, INCORPORATED** with office address at 32 Bicameral Road Violago Subd., Batasan Hills, Quezon City, represented by its President/General Manager, **MS. MYLENE L. BUMANGLAG**, hereinafter called the “**SERVICE PROVIDER**”.

WHEREAS, the DOLE invited Bids for certain goods and ancillary services, viz., “**Supply and Delivery of Five (5) Gallon Purified Drinking Water for Officials and Employees of the DOLE – Central Office for a Period of One (1) Year**” and the DOLE has accepted a total Bid for **Six Hundred Thousand Pesos only (₱600,000.00)** hereinafter called the “**Contract Price**”.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications/Terms of Reference; and
 - iii. General and Special Conditions of Contract;
 - ii. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder’s conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration for the sum of **Six Hundred Thousand Pesos only (₱600,000.00)** or such other sums as may be ascertained, **Pishon Industries, Incorporated** agrees to **Supply and Delivery of Five (5) Gallon Purified Drinking Water for Officials and Employees of the DOLE – Central Office for a Period of One (1) Year** in accordance with his/her/its Bid.
4. The DOLE agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.




