**DECLARING MKS FURNITURE AS THE SECOND LOWEST CALCULATED
AND RESPONSIVE BIDDER FOR THE PROJECT "SUPPLY AND DELIVERY OF
VARIOUS OFFICE FURNITURE AND EQUIPMENT FOR THE OFFICE OF
ASSISTANT SECRETARY VICTOR DEL ROSARIO"**

WHEREAS, the Department of Labor and Employment (DOLE), through the Administrative Service (AS), requisitioned for the project "Supply and Delivery of Various Office Furniture and Equipment for the office of Assistant Secretary Victor Del Rosario" with a total Approved Budget for the Contract of ₱107,900.00;

WHEREAS, the BAC Resolution No. 027, Series of 2021 Recommending Small Value Procurement as the method of procurement for the abovementioned project was signed on 22 February 2021;

WHEREAS, DOLE advertised the Request for Price Quotation for the bidding of the above-mentioned project in the Philippine Government E-Procurement Systems (PhilGEPS), DOLE website from 23 February 2021 to 01 March 2021;

WHEREAS, in response to the advertisement, two (2) bidders, namely: (1) New AG Stylist Furniture Quality Home and Office Furniture; and (2) MKS Furniture submitted its price proposals and is summarized in the Abstract of Price Quotations attached as Annex A, wherein New AG Stylist Furniture Quality Home and Office Furniture declared as Lowest Calculated Bidder;

WHEREAS, based on the Abstract for Price Quotation Submitted by BAC-TWG, New AG Stylist Furniture Quality Home and Office Furniture and MKS Furniture complied with the minimum requirements and its bid is below the approved budget of the contract for the project "Supply and Delivery of Various Office Furniture and Equipment for the office of Assistant Secretary Victor Del Rosario";

WHEREAS, New AG Stylist Furniture Quality Home and Office Furniture submitted its financial and eligibility documents for post-qualification;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by New AG Stylist Furniture Quality Home and Office Furniture its bid has been found to be non-responsive due to failed submission of 2021 Mayor's Permit;

WHEREAS, the BAC sent a letter to New AG Stylist Furniture Quality Home and Office Furniture to file a Motion for Reconsideration (MR) within three (3) calendar days;

WHEREAS, No MR was received by the BAC Secretariat from New AG Stylist Furniture Quality Home and Office Furniture;

WHEREAS, the BAC-Technical Working Group (TWG) recommended, MKS Furniture, the Second Lowest Calculated Bidder for post-qualification;

WHEREAS, the BAC-Technical Working Group (TWG) recommended, **MKS Furniture** as the **Second Lowest Calculated and Responsive Bidder** for the project **"Supply and Delivery of Various Office Furniture and Equipment for the office of Assistant Secretary Victor Del Rosario"** based on the Abstract of Price Quotation and was declared **responsive** as indicated in the post-qualification report under Small Value Procurement;

NOW, THEREFORE, for and in consideration of the foregoing, **We**, the members of the DOLE BAC hereby resolves as it is hereby **RESOLVED** that:

- a. To award the procurement of the project **"Supply and Delivery of Various Office Furniture and Equipment for the office of Assistant Secretary Victor Del Rosario"** to **MKS Furniture** via **Small Value Procurement**; and
- b. To recommend for approval by the DOLE Undersecretary the foregoing findings.
