DOLE BAC Resolution No. 31-A

DECLARING KNIT & TUCK MERCHANDISING AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT "SUPPLY AND DELIVERY OF 638 PIECES ADVOCACY SHIRT WITH PRINT FOR 2021 NATIONAL WOMEN'S MONTH CELEBRATION"

WHEREAS, the Department of Labor and Employment (DOLE), thru the Human Resource Development Service (HRDS), requisitioned for the Supply and Delivery of 638 Pieces Advocacy Shirt with Print for 2021 National Women's Month Celebration" with a total Approved Budget for the Contract of ₱178,640.00;

WHEREAS, the BAC recommended Small Value Procurement as the method of procurement to be adopted for the above-mentioned project as per approved BAC Resolution No. 31, Series of 2020;

WHEREAS, DOLE advertised the Request for Price Quotation for the bidding of the above-mentioned project in the Philippine Government e-Procurement System (PhilGEPS) and DOLE websites from 26 February 2021 to 01 March 2021;

WHEREAS, in response to the advertisement, four (4) prospective bidders, namely: (1) Knit & Tuck Merchandising; (2) AVECILLA TRADING; (3) ZIONEYES GENERAL MERCHANDISE; and (4) CEBOOM ENTERPRISES submitted their bid proposals before the deadline for the submission and receipt of bids;

WHEREAS, the BAC-Technical Working Group (TWG) in its Abstract of Price Quotations examined and evaluated the bid proposals of the four (4) bidders, to wit:

WHEREAS, based on the foregoing evaluation, Ceboom Enterprises submitted the lowest bid price for the said project;

WHEREAS, on 08 March 2021, Ceboom Enterprises submitted its post-qualification requirements;

WHEREAS, the BAC-TWG conducted post-qualification on the eligibility and financial documents submitted by Ceboom Enterprises. However, said bidder was declared as “non-responsive” due to non-submission of a valid Business Permit/Mayor’s Permit on or before the deadline. Hence, the BAC-TWG conducted post-qualification to the second lowest bidder, Knit & Tuck Merchandising;

WHEREAS, on 16 March 2021, the BAC issued a Notice of Post-Disqualification to Ceboom Enterprises and submitted its Motion for Reconsideration the following day;

WHEREAS, on 19 March 2021, the BAC denied its Motion for Reconsideration;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Knit & Tuck Merchandising, its bid has been found to be responsive;

NOW, THEREFORE, for and in consideration of the foregoing, we, the members of the Bids and Awards Committee, by virtue of the powers vested on us by law, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a) To declare **Knit & Tuck Merchandising** as the Lowest Calculated and Responsive Bidder for the project “**Supply and Delivery of 638 Pieces Advocacy Shirt with Print for 2021 National Women’s Month Celebration**”;
- b) To award the contract of the project “**Supply and Delivery of 638 Pieces Advocacy Shirt with Print for 2021 National Women’s Month Celebration**” to **Knit & Tuck Merchandising** at a total contract price of **₱127,600.00**; and
- c) To recommend for approval by the DOLE Undersecretary the foregoing findings.
