**CONTRACT AGREEMENT**

THIS AGREEMENT, made this 12 APR 2021 day of \_\_\_\_\_, 2021 between the **DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE)**, with office address at DOLE Main Building, Muralla Wing cor. General Luna Street, Intramuros, Manila, represented by **UNDERSECRETARY RENATO L. EBARLE**, hereinafter called the “**DOLE**” and **CONVERGE INFORMATION AND COMMUNICATION TECHNOLOGY SOLUTIONS, INC.**, with office address at Reliance Center Annex 1, 99 E. Rodriguez Jr., Avenue, Bo. Ugong, Pasig City, represented by its Key Account Manager, **MS. KATRINA B. FELICIANO**, hereinafter called the “**SERVICE PROVIDER**”.

**WHEREAS**, the **DOLE** invited Bids for certain goods and ancillary services, particularly, **Renewal of Contract for the Subscription of 30Mbps Internet Leased Line Connection via Fiber Optic Cable for Six (6) Months for the Bureau of Local Employment** and the **DOLE** has accepted a total Bid for **One Hundred Sixty-four Thousand Nine Hundred Seventy-six Pesos only (P164,976.00)** hereinafter called the “**Contract Price**”.

**NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:**

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Terms of Reference;
  - ii. Assessment Report on the Internet Service Subscription;
  - iii. Converge Information and Communication Technology Solutions, Inc. Proposal to Provide Internet Service;
  - iv. Notice of Award of Contract; and the Bidder’s conforme thereto;
  - v. Performance Security; and
  - vi. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. The **Service Provider** agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **One Hundred Sixty-four Thousand Nine Hundred Seventy-six Pesos only (₱164,976.00)** or such other sums as may be ascertained, the **Service Provider** agrees to provide **Subscription of 30Mbps Internet Leased Line Connection via Fiber Optic Cable for Six (6) Months for the Bureau of Local Employment** in accordance with its Bid.
4. The **DOLE** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.


