DECLARING ROSHQ TRADING AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT “SUPPLY AND DELIVERY OF EIGHT HUNDRED FORTY-FOUR (844) BOXES OF DISPOSABLE SURGICAL MASKS FOR THE DOLE – CENTRAL OFFICE OFFICIALS AND EMPLOYEES”

WHEREAS, the Department of Labor and Employment (DOLE), thru the Human Resource Development Service (HRDS), requisitioned for the supply and delivery of eight hundred forty-four (844) boxes of disposable surgical masks for the DOLE - Central Office Officials and Employees with a total Approved Budget for the Contract of ₱168,800.00;

WHEREAS, the BAC recommended Small Value Procurement as the method of procurement to be adopted for the above-mentioned project as per approved BAC Resolution No. 30, Series of 2020;

WHEREAS, DOLE advertised the Request for Price Quotation for the bidding of the above-mentioned project in the Philippine Government e-Procurement System (PhilGEPS) and DOLE websites from 26 February 2021 to 01 March 2021;

WHEREAS, in response to the advertisement, five (5) prospective bidders, namely: (1) AVECILLA Trading; (2) Pinnacle Supplies and Services Unlimited, Inc.; (3) ROSHQ Trading; (4) Persabe Merchandising; and (5) BDM Enterprises, Inc. submitted their bid proposals before the deadline for the submission and receipt of bids;

WHEREAS, the BAC-Technical Working Group (TWG) in its Abstract of Price Quotations examined and evaluated the bid proposals of the five (5) bidders, to wit:

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by ROSHQ Trading, its bid has been found to be responsive;



- b) To award the contract of the project “**Supply and Delivery of Eight Hundred Forty-four (844) Boxes of Disposable Surgical Masks for the DOLE – Central Office Officials and Employees**” to **ROSHQ Trading** at a total contract price of **₱91,152.00**; and
- c) To recommend for approval by the DOLE Undersecretary the foregoing findings.






