CONTRACT AGREEMENT

THIS AGREEMENT, made this APR 15 day of 2021, 2021 by and between the **DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE)**, with office address at DOLE Main Building, Intramuros, Manila, represented by **Undersecretary RENATO L. EBARLE**, hereinafter called the “**DOLE**” and **MAILTAG ORTIGAS CORPORATION** with office address at U117, G/F, Grand Emerald Tower Ruby Corner Garnet Road Ortigas Center, Pasig City represented by its President, **MR. JOSELITO LUCAS A. TAYZON**, hereinafter called the “**Service Provider**”.

WHEREAS, the **DOLE** invited Bids for certain goods and ancillary services, viz., for Lot 2 (International) of the project “**Provision of Courier Services for a Period of One (1) Year in the DOLE-Central Office (Mails and Parcels) – Re-Bidding**” for the **Administrative Service’s** and the **DOLE** has accepted a total Bid of **One Million Seven Hundred Sixty-Two Thousand One Hundred Seventy-Four Pesos only (₱1,762,174.00)** hereinafter called the “**Contract Price**”.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of the Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications and Terms of Reference;
 - iii. General Conditions of Contract;
 - iv. Special Conditions of Contract;
 - b. Winning bidder’s bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents / statements submitted;

Bid form including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarification on the bid), including corrections to the bid, if any, resulting from the Procuring Entity’s bid evaluation;
 - c. Notice of Award of Contract and Bidder’s conforme thereto;
 - d. Performance Security; and

- e. Other Contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice To Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
4. In consideration for the sum of **One Million Seven Hundred Sixty-Two Thousand One Hundred Seventy-Four Pesos only (₱1,762,174.00)** or such other sums as may be ascertained, the Service Provider agrees to provide **Lot 2 (International)** of the project **“Provision of Courier Services for a Period of One (1) Year in the DOLE-Central Office (Mails and Parcels) – Re-Bidding”** in accordance with its Bid.
5. The **DOLE** agrees to pay the above-mentioned sum in accordance with the terms of the bidding.




