## BAC Resolution No. 049 Series of 2021

DECLARING PACIFIC CROSS INSURANCE, INC. AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT "COMPREHENSIVE HEALTH CARE AND MEDICAL SERVICE PLAN OF THE OVERSEAS PERSONNEL ASSIGNED IN THE PHILIPPINE OVERSEAS LABOR OFFICES (POLOs)"- RE-BIDDING

WHEREAS, BAC Resolution No. 42, Series of 2021 declaring the bidding for the abovementioned project a failure was approved on 10 May 2021;

WHEREAS, the Department of Labor and Employment (DOLE) re-advertised the Invitation to Bid for the above-mentioned project with an Approved Budget for the Contract (ABC) of ₱37,491,762.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE website, and conspicuous places at the DOLE's premises from 11 May to 01 June 2021;

**WHEREAS**, said project is included in the approved Fiscal Year (FY) 2021 Annual Procurement Plan of the Department;

WHEREAS, the Pre-bid Conference via Zoom Platform scheduled on 18 May 2021 was attended by two (2) bidders, namely: 1) Pacific Cross Insurance, Inc., and 2) Etiqa Life and General Assurance, Inc.;

WHEREAS, in response to the advertisement, only Pacific Cross Insurance, Inc. purchased the bidding documents from the DOLE Bids and Awards Committee (BAC) Secretariat;

WHEREAS, on the Submission and Opening of Bids scheduled on 01 June 2021, only Pacific Cross Insurance, Inc. attended. Said bidder submitted its technical and financial envelopes. After the preliminary examination, the eligibility and technical requirements of the bidder was rated as "passed". Hence, the BAC - Technical Working Group (BAC-TWG) opened the financial envelope which was likewise found to be compliant and recommended for bid evaluation:

WHEREAS, based on the evaluation of the bids conducted by the DOLE BAC Technical Working Group on 01 June 2021, Pacific Cross Insurance, Inc. was declared as the Single Calculated Bidder per BAC Resolution No. 047, Series of 2021 for the project "Comprehensive Health Care and Medical Service Plan of the Overseas

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Pacific Cross Insurance, Inc. its bid has been found to be responsive;

**NOW, THEREFORE**, We, the members of the DOLE Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare Pacific Cross Insurance, Inc. as the Single Calculated and Responsive Bidder for the project "Comprehensive Health Care and Medical Service Plan of the Overseas Personnel Assigned in the Philippine Overseas Labor Offices (POLOs)"-Re-Bidding;
- b. To award the "Comprehensive Health Care and Medical Service Plan of the Overseas Personnel Assigned in the Philippine Overseas Labor Offices (POLOs)"-Re-Bidding to Pacific Cross Insurance, Inc.; and
- c. To recommend for approval by the DOLE Secretary the foregoing findings
