**DECLARING PEOPLE DYNAMICS, INC. AS THE SINGLE CALCULATED
AND RESPONSIVE BIDDER FOR THE PROJECT "USE OF ONLINE
ASSESSMENT/TESTING FOR ONE (1) YEAR"**

WHEREAS, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the above-mentioned project with an Approved Budget for the Contract (ABC) of ₱280,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE website, and conspicuous places at the DOLE's premises from 19 May to 08 June 2021;

WHEREAS, said project is included in the approved Fiscal Year (FY) 2021 Annual Procurement Plan of the Department;

WHEREAS, the Pre-bid Conference via Zoom Platform scheduled on 25 May 2021 was attended by two (2) bidders, namely: 1) People Dynamics, Inc., and 2) SFI Career Center;

WHEREAS, in response to the advertisement, only People Dynamics, Inc. purchased the bidding documents from the DOLE Bids and Awards Committee (BAC) Secretariat;

WHEREAS, on the Submission and Opening of Bids scheduled on 08 June 2021, only People Dynamics, Inc. attended. Said bidder submitted its technical and financial envelopes. After the preliminary examination, the eligibility and technical requirements of the bidder was rated as "**passed**". Hence, the BAC - Technical Working Group (BAC-TWG) opened the financial envelope which was likewise found to be compliant and recommended for bid evaluation;

WHEREAS, based on the evaluation of the bids conducted by the DOLE BAC Technical Working Group on 10 June 2021, **People Dynamics, Inc.** was declared as the Single Calculated Bidder per BAC Resolution No. 050, Series of 2021 for the project "**Use of Online Assessment/Testing for One (1) Year**";


