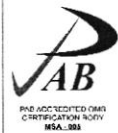

DECLARING SOCOTEC CERTIFICATION PHILIPPINES, INC. (FORMERLY AJA REGISTRARS, INC.) AS THE SINGLE RATED AND RESPONSIVE BIDDER FOR THE PROJECT “ENGAGEMENT OF SERVICES OF AN ISO CERTIFICATION BODY FOR ISO 9001:2015 RE-CERTIFICATION AND SURVEILLANCE AUDIT OF THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) OFFICE OF THE SECRETARY, SEVEN (7) SERVICES, SIX (6) BUREAUS AND ITS TWO (2) ATTACHED AGENCIES: NATIONAL CONCILIATION AND MEDIATION BOARD (NCMB) AND NATIONAL LABOR RELATIONS COMMISSION (NLRC)”

WHEREAS, the Department of Labor and Employment (DOLE) advertised the Request for Expression of Interest for the abovementioned project with an Approved Budget for the Contract (ABC) of ₱1,300,000.00 in the Philippine Government E-Procurement System (PhilGEPS) and DOLE websites and conspicuous places at the DOLE’s premises from 08 April 2021 to 04 May 2021;

WHEREAS, said project is included in the 2021 Annual Procurement Plan of the Department;

WHEREAS, in response to the advertisement, only SOCOTEC Certification Philippines, Inc. (formerly AJA Registrars, Inc.) submitted a Letter of Intent signifying its interest to participate in the bidding on 14 April 2021;

WHEREAS, the submission and opening of eligibility documents scheduled on 15 April 2021 was attended only by SOCOTEC Certification Philippines, Inc. Upon eligibility check, said bidder was declared eligible;

WHEREAS, the BAC Technical Working Group (TWG) examined and evaluated the eligibility documents submitted by SOCOTEC Certification Philippines, Inc. using the Shortlist Criteria in the Annex A of the Terms of Reference;

WHEREAS, BAC Resolution No. 038, Series of 2021, SOCOTEC Certification Philippines, Inc. was declared as the Lone Shortlisted Consultant;

WHEREAS, in view of unavoidable circumstances, the BAC issued a Notice of Postponement informing the bidder that the schedule of the Pre-bid Conference has been moved from 20 April 2021 to 23 April 2021;

WHEREAS, on 21 April 2021, the BAC Secretariat sent notice to SOCOTEC Certification Philippines, Inc., informing its eligibility for the project;

WHEREAS, SOCOTEC Certification Philippines, Inc. attended the Pre-bid Conference scheduled on 23 April 2021;

WHEREAS, the BAC issued Notice of Postponement on the schedule of the Submission and Opening of Technical and Financial Proposals to inform the bidder that the schedule has been moved from 04 May 2021, 9:30 a.m. to 06 May 2021, 2:00 p.m.;

WHEREAS, during the submission and opening of technical and financial proposals, SOCOTEC Certification Philippines, Inc. submitted its two envelopes containing the technical and financial proposals;

WHEREAS, pursuant to Sections 33.2.1.b and 33.2.2 of the 2016 Revised IRR of RA 9184, the BAC-TWG conducted a quality cost-based evaluation on the technical and financial proposals of SOCOTEC Certification Philippines, Inc.;

WHEREAS, pursuant to approved BAC Resolution No. 043, Series of 2021, SOCOTEC Certification Philippines, Inc. was declared as Single Rated Bidder;

WHEREAS, on 11 May 2021, the BAC negotiated with SOCOTEC Certification Philippines, Inc. pursuant to Section 33.2.5 of the 2016 Revised IRR of RA 9184;

WHEREAS, the BAC-TWG conducted post-qualification on all the documents submitted by SOCOTEC Certification Philippines, Inc.;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by SOCOTEC Certification Philippines, Inc., its bid has been found to be responsive;


NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare **SOCOTEC Certification Philippines, Inc.** as the Single Rated and Responsive Bidder for the project “**Engagement of Services of an ISO Certification Body for ISO 9001:2015 Re-certification and Surveillance Audit of the Department of Labor and Employment (DOLE) Office of the Secretary, Seven (7) Services, Six (6) Bureaus and its Two (2) Attached Agencies: National Conciliation and Mediation Board (NCMB) and National Labor Relations Commission (NLRC)**”;
- b. To award the project “**Engagement of Services of an ISO Certification Body for ISO 9001:2015 Re-certification and Surveillance Audit of the Department of Labor and Employment (DOLE) Office of the Secretary, Seven (7) Services, Six (6) Bureaus and its Two (2) Attached Agencies: National Conciliation and Mediation Board (NCMB) and National Labor Relations Commission (NLRC)**” to **SOCOTEC Certification Philippines, Inc.** at a contract price of **₱1,238,137.60**; and
- c. To recommend for the approval by the DOLE Undersecretary the foregoing findings.




