**DECLARING THE COMPETITIVE BIDDING FOR THE PROJECT
“COMPREHENSIVE HEALTH CARE AND MEDICAL SERVICE PLAN OF
THE OVERSEAS PERSONNEL ASSIGNED IN THE PHILIPPINE
OVERSEAS LABOR OFFICES” A FAILURE**

WHEREAS, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the above-mentioned project with an Approved Budget for the Contract (ABC) of ₱37,491,762.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE website, and conspicuous places at the DOLE's premises from 06 April 2021 to 06 May 2021;

WHEREAS, said project is included in the approved Fiscal Year (FY) 2021 Indicative Annual Procurement Plan of the Department;

WHEREAS, the Pre-bid Conference scheduled on 15 April 2021 was attended only by Pacific Cross Philippines;

WHEREAS, in response to the advertisement, only Pacific Cross Philippines purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat;

WHEREAS, the submission and opening of bids originally scheduled on 27 April 2021 has been moved to 06 May 2021, was attended only by Pacific Cross Philippines. Said bidder submitted its technical and financial envelopes. On the opening of bids, the bid was rated as “**failed**” due to non-compliance on the submission of separate envelopes as indicated in Section VIII. Checklist of Technical and Financial Documents;

NOW, THEREFORE, for and in consideration of the foregoing, we, the members of the DOLE Bids and Awards Committee, by virtue of the powers vested on us by law, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare the competitive bidding a “failure” due to non-compliance on the submission of separate envelopes as indicated in Section VIII. Checklist of Technical and Financial Documents;
- b. To recommend that a re-bidding be conducted; and
- c. To recommend for approval by the DOLE Secretary the foregoing findings.

RESOLVED, at the DOLE Main Building, Intramuros, Manila, this 6th day of May 2021.




