CONTRACT AGREEMENT

THIS AGREEMENT, made this ____ day of 14 JUN 2021, 2021 by and between the **DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE)**, with office address at DOLE Main Building, Intramuros, Manila, represented by **Undersecretary RENATO L. EBARLE**, hereinafter called the “**DOLE**” and **REMAX INTERNATIONAL, INC.** with office address at 18 United Street, Kapitolyo, Pasig City represented by its Network & Security Systems Unit Head, **MR. BRIAN D. TAN**, hereinafter called the “**Supplier**”.

WHEREAS, the **DOLE** invited Bids for certain goods and ancillary services, viz., for Lot 1 - Laptop Computers (Branded-Brand New), Lot 2 - High-end Laptop Computers (Branded-Brand New) and Lot 3 - HD Webcam (New-Branded) of the project “**Supply and Delivery of Various ICT Equipment for DOLE Office Productivity**” for the **Planning Service** and the **DOLE** has accepted a total Bid of **Six Hundred Seventy-Four Thousand Eight Hundred Sixty-Five Pesos and Sixty-Six Centavos only (P674,865.66)** hereinafter called the “**Contract Price**”.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of the Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications and Terms of Reference;
 - iii. General Conditions of Contract;
 - iv. Special Conditions of Contract;
 - b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents / statements submitted;

Bid form including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarification on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - c. Notice of Award of Contract and Bidder's conforme thereto;
 - d. Performance Security;

- e. Purchase Order; and
 - f. Other Contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice To Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
4. In consideration for the sum of **Six Hundred Seventy-Four Thousand Eight Hundred Sixty-Five Pesos and Sixty-Six Centavos only (P674,865.66)** or such other sums as may be ascertained, the Supplier agrees to supply Lot 1 - Laptop Computers (Branded-Brand New), Lot 2 - High-end Laptop Computers (Branded-Brand New) and Lot 3 - HD Webcam (New-Branded) for the project **“Supply and Delivery of Various ICT Equipment for DOLE Office Productivity”** of the **Planning Service** in accordance with its Bid.
5. The **DOLE** agrees to pay the above-mentioned sum in accordance with the terms of the bidding.






