CONTRACT AGREEMENT

THIS AGREEMENT, made this 24th day of July, 2021 between the **DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE)** with office address at DOLE Main Building, Muralla Wing cor. General Luna Street, Intramuros, Manila, represented by **UNDERSECRETARY RENATO L. EBARLE**, herein called the “**DOLE**” and **EASTERN TELECOMMUNICATIONS PHILIPPINES, INC.** with office address at Telecom Plaza, 316 Sen. Gil J. Puyat Ave., Salcedo Village, Makati City represented by its Sales Head, **MR. MICHAEL S. CASTAÑEDA**, hereinafter called the “**SERVICE PROVIDER**”.

WHEREAS, the **DOLE** invited Bids for certain goods and ancillary services, particularly, Renewal of Contract for the project “**Subscription of 150 Mbps Internet Leased Line Connection for One (1) Year (Primary) for the Planning Service**” and the **DOLE** has accepted a total Bid for only (**₱1,061,760.000**) hereinafter called the “**Contract Price**”.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Terms of Reference;
 - ii. Assessment Report on the Internet Service Subscription;
 - iii. Eastern Telecommunications Philippines, Inc. proposal to Provide Internet Service;
 - iv. Notice of Award of Contract; and the Bidder’s conforme thereto;
 - v. Performance Security; and
 - vi. Other contract documents that may be required by existing laws and/or the DOLE. The **Service Provider** agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **One Million Sixty-one Thousand Seven Hundred Sixty Pesos (₱1,061,760.000)** or such other sums as may be ascertained, the **Service Provider**

agrees to provide **Subscription of 150 Mbps Internet Leased Line Connection for One (1) Year (Primary) for the Planning Service** in accordance with its Bid.

4. The **DOLE** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.






