DECLARING LAKBAWAYAN ENTERPRISE AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT “SUPPLY AND DELIVERY OF VARIOUS EVENT COLLATERALS, TOKENS AND SOUVENIRS FOR THE VIRTUAL CONDUCT OF THE JOINT TGRS-NERS TASK FORCE JOB SUMMIT”

WHEREAS, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the competitive bidding conducted for the above-mentioned project with an Approved Budget for the Contract (ABC) of ₱405,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE website and conspicuous places at the DOLE’s premises from 23 June 2021 to 20 July 2021;

WHEREAS, the above-mentioned project is included in FY 2021 Annual Procurement Plan of the Department;

WHEREAS, in response to the advertisement, Tanjer Enterprises and Lakbawayan Enterprise purchased the bidding documents from the DOLE Bids and Awards Committee (BAC) Secretariat;

WHEREAS, the Pre-bid Conference scheduled on 06 July 2021 was attended by three (3) bidders, namely: (1) Tanjer Enterprises; (2) Lakbawayan Enterprise; and (3) First Fruit Printing;

WHEREAS, the submission and opening of bids originally scheduled on 20 July 2021 was rescheduled to 23 July 2021;

WHEREAS, during the submission and opening of bids, Tanjer Enterprises and Lakbawayan Enterprise submitted their two envelopes containing the eligibility, technical and financial requirements. Upon eligibility check, the technical component of the two (2) bidders were rated as “passed”. Hence the BAC - Technical Working Group (TWG) opened the financial envelopes which were likewise found to be compliant and recommended for bid evaluation;

WHEREAS, the BAC instructed the BAC-TWG to conduct a detailed evaluation of bids and prepare the necessary Bid Evaluation Report;

WHEREAS, based on the evaluation of the bids conducted by the DOLE-BAC TWG, Lakbawayan Enterprise was declared as the Lowest Calculated Bidder per BAC Resolution No. 062, Series of 2021;

WHEREAS, on 29 July 2021, the BAC Secretariat sent a notice to Lakbawayan Enterprise, requesting for submission of post-qualification documents;

WHEREAS, on 30 July 2021, Lakbawayan Enterprise submitted their post-qualification documents;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Lakbawayan Enterprise, its bid has been found to be responsive;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare Lakbawayan Enterprise as the Lowest Calculated and Responsive Bidder for the project “**Supply and Delivery of Various Event Collaterals, Tokens and Souvenirs for the Virtual Conduct of the Joint TGERS-NERS Task Force Job Summit**”;
- b. To award the project “**Supply and Delivery of Various Event Collaterals, Tokens and Souvenirs for the Virtual Conduct of the Joint TGERS-NERS Task Force Job Summit**” to Lakbawayan Enterprise at a contract price of **₱ 317,250.00**; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.




