**DECLARING BUSINESS UNUSUAL MEDIA SOLUTIONS, INC.
AS THE LOWEST CALCULATED AND RESPONSIVE BIDDER FOR
THE BUREAU OF LOCAL EMPLOYMENT PROJECT “PHOTO AND VIDEO
COVERAGE AND PRODUCTION WITH SAME-DAY-EDIT DURING THE 21ST
NATIONAL PESO CONGRESS – RE-BIDDING”**

WHEREAS, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the abovementioned project with an Approved Budget for the Contract (ABC) of ₱400,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE Website and conspicuous places at the DOLE’s premises from 17 August 2021 to 25 August 2021;

WHEREAS, said project is included in the FY 2021 Annual Procurement Plan of the Department;

WHEREAS, in response to the advertisement, three (3) bidders namely: (1) Exposure Photo and Video; (2) Business Unusual Media Solutions, Inc.; and (3) M&P Productions Co. purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat on 23 August 2021 to 24 August 2021;

WHEREAS, the submission and opening of bids scheduled on 25 August 2021 was attended by three (3) bidders namely: (1) Exposure Photo and Video; (2) Business Unusual Media Solutions, Inc.; and (3) M&P Productions Co. Said bidders submitted their technical and financial envelopes. After preliminary examination, the technical proposals of Exposure Photo and Video and Business Unusual Media Solutions, Inc. were rated as “**passed**” while M&P Productions Co. was rated as “**failed**” in view of its non-compliance with the form for the Technical Specification in relation to Section VII (Technical Specifications) of the Bid Documents; hence, the BAC opened the financial envelopes of Exposure Photo and Video and Business Unusual Media Solutions, Inc. which were also rated as “**passed**”;

WHEREAS, the BAC informed the representative of M&P Productions Co. that they have an option to file for a Motion for Reconsideration (MR) within three (3) days from the date of opening of bids;

WHEREAS, Motion for Reconsideration (MR) was denied in view of its non-compliance with the form for the Technical Specification in relation to Section VII (Technical Specifications) of the Bid Documents;

WHEREAS, the BAC - TWG in its bid evaluation report dated 25 August 2021 as duly concurred by the members of the BAC, examined and evaluated the bid proposals of Business Unusual Media Solutions and Exposure Photo and Video, Inc.;

WHEREAS, based on the evaluation of the bids conducted by the DOLE-BAC Technical Working Group, Business Unusual Media Solutions, Inc. and Exposure Photo and Video complied with the mandatory minimum specifications of the said project. Business Unusual Media Solutions, Inc. was declared as the Lowest Calculated Bidder per BAC Resolution No. 073, Series of 2021;

WHEREAS, BAC Secretariat sent a letter to Business Unusual Media Solutions, Inc. requesting for submission of post-qualification documents;

WHEREAS, Business Unusual Media Solutions, Inc. submitted additional documents for post-qualification;

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by Business Unusual Media Solutions, Inc., its bid has been found to be responsive;

NOW, THEREFORE, We, the members of the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare **Business Unusual Media Solutions, Inc.** as the **Lowest Calculated and Responsive Bidder** for the **Bureau of Local Employment** project **“Photo and Video Coverage and Production with Same-Day-Edit during the 21st National PESO Congress – Re-Bidding”**;
- b. To award the project **“Photo and Video Coverage and Production with Same-Day-Edit during the 21st National PESO Congress – Re-Bidding”** for the **Bureau of Local Employment** to **Business Unusual Media Solutions, Inc.**; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.
