**DECLARING ANGLOWEALTH ENTERPRISES AS THE LOWEST
CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT "SUPPLY,
DELIVERY AND INSTALLATION OF ACRYLIC SHIELDS IN THE FINANCIAL
AND MANAGEMENT SERVICE"**

WHEREAS, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the above-mentioned project with an Approved Budget for the Contract (ABC) of ₱400,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE website, and conspicuous places at the DOLE's premises from 10 to 31 August 2021;

WHEREAS, said project is included in the approved Fiscal Year (FY) 2021 Annual Procurement Plan of the Department;

WHEREAS, the Pre-bid Conference via zoom platform scheduled on 17 July 2021, was attended by three (3) bidders, namely: 1) Graphic Wizard, Inc., 2) Filcrafters, Inc., and 3) Gober Technologies Corporation;

WHEREAS, in response to the advertisement, five (5) bidders, namely: 1) Gober Technologies Corp., 2) Smart Advertising & Events, Inc., 3) Ideamax Designs, Inc., 4) Graphic Wizard, Inc., and 5) Anglowealth Enterprises purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat;

WHEREAS, on the submission and opening of bids scheduled on 31 August 2021 three (3) bidders, namely: 1) Ideamax Designs, Inc., 2) Anglowealth Enterprises, and 3) Graphic Wizard, Inc. attended. Said bidders submitted their technical and financial envelopes. After the preliminary examination, the eligibility and technical requirements of the two (2) bidders, namely: 1) Ideamax Designs, Inc., and 2) Anglowealth Enterprises were rated as "**passed**" while Graphic Wizard, Inc. was rated as "**failed**" due to unnotarized Bid Securing Declaration. Hence, the BAC - Technical Working Group (BAC-TWG) opened the financial envelopes of the two (2) eligible bidders which were likewise found to be compliant and recommended for bid evaluation;

WHEREAS, based on the evaluation of the bids conducted by the DOLE BAC Technical Working Group on 2 September 2021, Anglowealth Enterprises was declared as the Lowest Calculated Bidder per BAC Resolution No. 78, Series of

2021 for the project “**Supply, Delivery and Installation of Acrylic Shields in the Financial and Management Service;**

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by **Anglowealth Enterprises** its bid has been found to be responsive;

NOW, THEREFORE, We, the members of the DOLE Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare **Anglowealth Enterprises** as the Lowest Calculated and Responsive Bidder for the project “*Supply, Delivery and Installation of Acrylic Shields in the Financial and Management Service;*”
- b. To award the project “**Supply, Delivery and Installation of Acrylic Shields in the Financial and Management Service** to **Anglowealth Enterprises**; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings
