**DECLARING DCI INTERNATIONAL I.T. SOLUTIONS & SERVICES CORP.
AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR LOT 1
AND PRONET SYSTEMS INTEGRATED NETWORK SOLUTIONS, INC.
AS THE SINGLE CALCULATED AND RESPONSIVE BIDDER FOR
LOTS 2, 3 AND 4 OF THE PROJECT "SUPPLY AND DELIVERY
OF VARIOUS ICT EQUIPMENT FOR THE BUREAU OF LOCAL EMPLOYMENT"**

WHEREAS, the Department of Labor and Employment (DOLE) advertised the Invitation to Bid for the above-mentioned project with an Approved Budget for the Contract (ABC) of ₱1,662,000.00 in the Philippine Government E-Procurement System (PhilGEPS), DOLE website, and conspicuous places at the DOLE's premises from 17 July 2021 to 10 August 2021;

WHEREAS, said project is included in the approved Fiscal Year (FY) 2021 Annual Procurement Plan of the Department;

WHEREAS, the Pre-bid Conference via zoom platform scheduled on 23 July 2021, was attended by four (4) bidders, namely: 1) Remax International, Inc., 2) Pronet Systems Integrated Network Solution, Inc., 3) DCI Int'l. I.T. Solutions & Services Corp., and 4) Quartz Business Products Corp.;

WHEREAS, Supplemental /Bid Bulletin No. 09, Series of 2021 to clarify or amend some provisions originally indicated in the Bidding Documents specifically on Sections VI and VII, Schedule of Requirements and Technical Specifications, respectively, was issued to the bidders;

WHEREAS, in response to the advertisement, two (2) bidders, namely: 1) DCI Int'l. I.T. Solutions & Services Corp., and 2) Pronet Systems Integrated Network Solution, Inc. purchased the bidding documents from the DOLE Bids and Awards Committee (DOLE BAC) Secretariat;

WHEREAS, on the submission and opening of bids originally scheduled on 3 August 2021 which was moved to 10 August 2021, two (2) bidders, namely: 1) DCI Int'l. I.T. Solutions & Services Corp., and 2) Pronet Systems Integrated Network Solution, Inc. submitted their bids which include their technical and financial

envelopes. After the preliminary examination, the eligibility and technical requirements of the bidders were rated as “**passed**”. Hence, the BAC - Technical Working Group (BAC-TWG) opened the financial envelopes which were likewise found to be compliant and recommended for bid evaluation;

WHEREAS, BAC Resolution No. 070, Series of 2021 declared **DCI International I.T. Solutions and Services Corp.** as the Single Calculated Bidder for lot 1 - 19 units Branded Mid-Size Laptop and **Pronet Systems Integrated Network Solution, Inc.** as the Single Calculated Bidder for the following:

- Lot 2 - 1 unit Heavy Duty Access Point;
- Lot 3 - 3 units Heavy Duty Access Point (Branded); and
- Lot 4 - 3 units Automatic Two-Side Document Scanner (Branded)

WHEREAS, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by DCI International I.T. Solutions and Services Corp. and Pronet Systems Integrated Network Solution, Inc., respectively, their bids have been found to be responsive;

NOW, THEREFORE, We, the members of the DOLE Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED**:

- a. To declare **DCI International I.T. Solutions and Services Corp.** as the Single Calculated Responsive Bidder for lot 1 and **Pronet Systems Integrated Network Solution, Inc.** as the Single Calculated and Responsive Bidder for lots 2, 3, and 4 of the project “***Supply and Delivery of Various ICT Equipment for the Bureau of Local Employment***”;
- b. To award the “*Supply and Delivery of Various ICT Equipment for the Bureau of Local Employment*” to **DCI International I.T. Solutions and Services Corp.** for lot 1 and to **Pronet Systems Integrated Network Solution, Inc.** for lots 2, 3, and 4; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings




