**DECLARING MMP AWARDS SPECIALIST AS THE SINGLE  
CALCULATED AND RESPONSIVE BIDDER FOR THE PROJECT  
“SUPPLY AND DELIVERY OF CUSTOMIZED PLAQUES AND TROPHIES  
FOR 2021 NATIONAL PESO CONGRESS, AWARDING OF 2020 BAYANIHAN  
SERVICE AWARDS PESO”**

**WHEREAS**, the Department of Labor and Employment (DOLE), through the Bureau of Local Employment (BLE), requisitioned for the project “Supply and Delivery of Customized Plaques and Trophies for 2021 National PESO Congress, Awarding of 2020 Bayanihan Service Awards PESO” with a total Approved Budget for the Contract of ₱566,500.00;

**WHEREAS**, the BAC Resolution No. 060, Series of 2021 recommending Small Value Procurement as the method of procurement for the abovementioned project was signed on 16 July 2021;

**WHEREAS**, DOLE advertised the Request for Price Quotation for the bidding of the above-mentioned project in the Philippine Government E-Procurement Systems (PhilGEPS), DOLE website from 17 July 2021 to 21 July 2021;

**WHEREAS**, in response to the advertisement, two (2) bidders, namely: (1) Ace - J Summit Innovations, Inc.; and (2) MMP Awards Specialist submitted their price proposals and is summarized in the Abstract of Price Quotations attached as Annex A, wherein MMP Awards Specialist declared as Single Calculated Bidder while Ace - J Summit Innovations, Inc. was disqualified since the bid price was higher than the approved budget of the contract;

**WHEREAS**, based on the Abstract for Price Quotation submitted by the BAC-TWG, MMP Awards Specialist complied with the minimum requirements and its bid is below the approved budget for the contact of the project “Supply and Delivery of Customized Plaques and Trophies for 2021 National PESO Congress, Awarding of 2020 Bayanihan Service Awards PESO”;

**WHEREAS**, MMP Awards Specialist submitted its financial and eligibility documents for post-qualification;

**WHEREAS**, upon careful examination, validation and verification of all the eligibility, technical and financial requirements submitted by MMP Awards Specialist its bid has been found to be responsive;

**WHEREAS**, the BAC-Technical Working Group (TWG) recommended, MMP Awards Specialist as the **Single Calculated and Responsive Bidder** for the **Bureau of Local Employment** project “**Supply and Delivery of Customized Plaques and Trophies for 2021 National PESO Congress, Awarding of 2020 Bayanihan Service Awards PESO**” based on the Abstract of Price Quotation and was declared **responsive** as indicated in the post-qualification report under Small Value Procurement;

**NOW, THEREFORE**, for and in consideration of the foregoing, **We**, the members of the DOLE BAC hereby resolves as it is hereby **RESOLVED** that:

- a. To declare **MMP Awards Specialist** as the **Single Calculated and Responsive Bidder** for the **Bureau of Local Employment** project “**Supply and Delivery of Customized Plaques and Trophies for 2021 National PESO Congress, Awarding of 2020 Bayanihan Service Awards PESO**”;
- b. To award the procurement of the project “**Supply and Delivery of Customized Plaques and Trophies for 2021 National PESO Congress, Awarding of 2020 Bayanihan Service Awards PESO**” to **MMP Awards Specialist** via **Small Value Procurement**; and
- c. To recommend for approval by the DOLE Undersecretary the foregoing findings.
